THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Pówers) (Cyprus) Order, 1946, I hereby order as follows:—

1. This Order may be cited as the Supplies and Services (Nicosia Electric Company Limited) Order, 1949.

AM. S. C. 1949, 6.10-49, 1.453. 2. In this Order the term-

"the Company" means the Nicosia Electric Company Limited; "the Municipality" means the Municipal Corporation of Nicosia:

"Agreements" means the Contract between the Company and the Municipality dated the 11th June, 1912, as amended by the contracts dated the 11th June, 1921, 7th April, 1928, 16th August, 1930, and 22nd April, 1932.

3. In respect of electrical energy supplied or made available by the Company to consumers for domestic supply including lighting and nondomestic lighting other than street lighting, street lighting and industrial power the methods by which the Company may charge consumers for electrical energy supplied or made available shall be, and the rates chargeable to consumers shall not exceed, those specified in the Schedule to this Order.

4. This Order shall come into operation on the 1st day of April, 1949, AM. 52.194 and shall remain in force up to the 30th September, 1949.

SCHEDULE. (Clause 3.)

I. For domestic supply including lighting and non-domesticlighting other than street lighting throughout the Company's authorized area of supply—

for every unit (kilowatthour) $4\frac{1}{2}$ copper piastres per unit with a minimum charge of two shillings per month in respect to consumers whose premises are situated outside the Municipal Boundaries as defined in the Agreements.

II. For street lighting-

(i) within the Municipal Boundaries at the rates and on the conditions set out in the Agreements;

(ii) outside the Municipal Boundaries 3 copper piastres per unit less 25%.

III. For industrial power throughout the Company's authorized area of supply-

(i)—(a) Tariff No. 1.—Over $\frac{1}{2}$ K.V.A. and up to and including 1 K.V.A. a minimum consumption of 15 units per month for a period of at least one year;

(b) over 1 K.V.A. a minimum consumption of 10 units per month for each additional K.V.A., or portion thereof, in addition to the 15 units per month for the first K.V.A. as prescribed under (a).

The minimum monthly consumption referred to in (a) and (b) hereinabove shall be charged and paid at $4\frac{1}{2}$ copper piastres per unit and all other and above that minimum

monthly consumption at 3 copper piastres per unit; (ii) Tariff No. 2.—Ten shillings per month per K.V.A. or portion thereof and in addition 2 copper piastres for each and every unit consumed and this for a period of not less than one year; (iii) Tariff No. 3.—For supplies of over 40 K.V.A. at ten shillings

per K.V.A. per month, and in addition 61 paras per unit, at price of Gas Oil not exceeding £15 per metric ton, subject to the following fuel clause, that is to say—

An increase or decrease of 3 paras per unit for an increase or decrease of £1 per metric ton of Gas Oil.
