No. 152. THE FOREST LAWS, 1939 AND 1948.

ORDER IN COUNCIL No. 2351
MADE UNDER SECTION 3.

In exercise of the powers vested in me by section 3 of the Forest Laws, 1939 and 1948, I, the Acting Governor, with the advice of the Executive Council, do hereby order as follows:—

1. This Order may be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) (Amendment) Order, 1949, and shall be read as one with the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to (No. 2) 1947 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to 1949.

2. The Schedule to the principal Order is hereby amended as follows:—

(a) by the deletion therefrom of the area No. 9 (relating to the village of Paleometokho) and the substitution therefor of the following area:—

"9. Paleometokho in the District of Nicosia:

- (a) A portion of the crown land under plot No. 227 of sheet XX, plan No. 63, at the locality "Mavromazka", demarcated by boundary stones, numbered consecutively from 1 to 34, inclusive, comprising 139 donums and 1 evlek approximately and shown on the Government Survey Plan Serial No. 1326, delineated thereon in green.
- (b) A portion of the crown land under plot No. 188/1 of sheet XX, plans Nos. 63 and 64, at the locality "Kafkalla", demarcated by boundary stones numbered consecutively from 1 to 32, inclusive, comprising 149 donums approximately and shown on the Government Survey Plan Serial No. 1388, delineated thereon in green".

(b) by the addition thereto, immediately after the area No. 35 (relating to the village of Tala), of the following areas:—

“36. Kyra in the District of Nicosia :

A portion of the crown land under plot 2/1 of sheet XX, plans Nos. 18 and 19, at the locality “Kafkalla tou Kapoutiou”, demarcated by boundary stones numbered consecutively from 1 to 20, inclusive, comprising 172 donums and two evleks approximately but excluding plots Nos. 3, 163, 2/2, 2/4 and 383.1 and shown on the Government Survey Plan Serial No. 1389, delineated thereon in green.

37. Philia in the District of Nicosia :

The whole area of the crown land under plot 63/2 of sheet XX, plan No. 28, at the locality “Arkoghadharos”, demarcated by boundary stones numbered consecutively from 1 to 10, inclusive, comprising 68 donums and one evlek approximately and shown on the Government Survey Plan Serial No. 1410, delineated thereon in green.

38. Skylloura in the District of Nicosia :

A portion of the crown land under plots Nos. 152/1 and 17 of sheet XX, plan No. 6, at the locality “Frangovounos”, demarcated by boundary stones numbered consecutively in red from 1 to 20, inclusive, and thence by boundary stones Nos. 23, 22, 21 and 20 of the Village Fuel Area of Ayia Marina Skyllouras; and thence by boundary stones Nos. 21 and 22 in red; and thence by boundary stones Nos. 13, 12, 11, 10, 9, 8, 7, 6, 5, 4 and 3 of the Ayia Marina Skyllouras Village Fuel Area, comprising 171 donums, one evlek and 1,400 sq. ft. approximately and shown on the Government Survey Plan Serial No. 1392, delineated thereon in green.

39. Ayia in the District of Nicosia :

(a) A portion of the crown land under plot 283 of sheet XXXI, plan No. 21 E.1 and 2, at the locality “Sebi Dagh”, demarcated by boundary stones numbered consecutively from 1 to 20, inclusive, comprising 81 donums approximately and shown on the Government Survey Plan Serial No. 1394, delineated thereon in green and marked “A”.

(b) A portion of the crown land under plot 294 of sheet XXXI, plan No. 21 E.2, at the locality “Topak Dagh”, demarcated by boundary stones numbered consecutively from 1 to 8, inclusive, comprising 19 donums, 2 evleks and 1,300 sq. ft. approximately and shown on the Government Survey Plan Serial No. 1394, delineated thereon in green and marked “B”.

40. Syrianokhori in the District of Nicosia :

The whole area of the crown land under plot No. 92 of sheet XIX, plan No. 14 situated at the locality “Livadhia”, demarcated by boundary stones numbered consecutively from 1 to 17, inclusive, comprising 118 donums and 2 evleks approximately and shown on the Government Survey Plan Serial No. 1409, delineated thereon in green”.
