**NOTICE UNDER SECTION 12.**

In exercise of the powers vested in me by section 12 of the Sheep and Goats (Shepherds' Licensing and Control) Law, 1948, I hereby direct that during the period between the 15th January, 1949 and the 31st May, 1949, flocks within the areas of the following villages shall, between the hours of sunset and sunrise, be kept inside an enclosure and not taken outside an enclosure :—
