THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1948.

RULES MADE UNDER SECTION 114.

In exercise of the powers vested in me by section 114 of the Municipal Corporations Laws, 1930 to 1948, I, the Acting Governor, with the advice of the Executive Council, do hereby make the following rules:—

1. These rules may be cited as the Municipal Corporations (Audit Fees) Amendment Rules, 1949, and shall be read as one with the Municipal Corporations (Audit Fees) Rules, 1940 (hereinafter referred to as "the principal Rules") and the principal Rules and these rules may together be cited as the Municipal Corporations (Audit Fees) Rules, 1940 and 1949.

2. The Schedule to the principal Rules is hereby amended by the insertion therein and immediately after item 1 thereof of the following item:—

THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1948.

ORDER MADE BY THE ACTING GOVERNOR UNDER SECTION 207 (1).

In exercise of the powers vested in me by section 207 (1) of the Municipal Corporations Laws, 1930 to 1948, I, the Acting Governor, do hereby order as follows:—

1. This Order may be cited as the Municipal Elections (Closing of Licensed Premises) (Lefka and Morphou) Order, 1949.

2. In this Order—

"licensed premises" means any premises licensed for the sale of intoxicating liquors by retail under the provisions of the Sale of Intoxicating Liquors Law, 1943.

3. Notwithstanding anything contained in the Sale of Intoxicating Liquors (Retailers Closing Hours) Orders, 1945 and 1949—

(a) all licensed premises situated within the municipal limits of the village of Lefka shall be closed and remain closed from 1.00 a.m. on the 8th day of May, 1949, until 6.00 a.m. on the 9th day of May, 1949;

(b) all licensed premises situated within the municipal limits of the village of Morphou shall be closed and remain closed from 1.00 a.m. on the 8th day of May, 1949, until 6.00 a.m. on the 9th day of May, 1949.
