- (d) that the sum borrowed shall, subject to the second proviso to paragraph (e) of this clause, be repayable by the Municipal Corporation to the Government in fifty equal annual instalments (comprising sinking fund and interest), the first instalment to become due one year after the final withdrawal has been made by the Municipal Corporation on completion of the work or the 31st December, 1950, whichever date is the earlier;
- (e) that interest accrued on the amounts withdrawn shall be paid yearly from the date of withdrawal until the final withdrawal has been made or until the 31st December, 1950, whichever date is the earlier:

Provided that any interest that may be outstanding on any amount already withdrawn on the date of the last withdrawal or on the 31st December, 1950, whichever date is the earlier, shall be paid on that date:

Provided further that if any withdrawal is made after the 31st December, 1950, the interest payable on the next annual instalment shall be adjusted accordingly;

- (f) that the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in its annual estimates as a charge on its revenues the sums payable as aforesaid in the year to which such estimates relate.
- 2. That for the purpose of securing the repayment of the sum under the loan, the Municipal Corporation is hereby authorized subject to any prior mortgage thereon, to mortgage to the Government all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation, and also all the houses to be erected including the land on which they will be erected and the water supply for those houses.

THE TRADING WITH THE ENEMY LAWS, 1939 TO 1945.

ORDER MADE BY THE ACTING GOVERNOR UNDER SECTIONS 3 (2) AND 12B.

R. E. TURNBULL,

Acting Governor.

In exercise of the powers vested in me by sections 3 (2) and 12B of the Trading with the Enemy Laws, 1939 to 1945 (hereinafter referred to as "the Law"), I, the Acting Governor, do hereby order as follows:—

- 1. This Order may be cited as the Trading with the Enemy (Authorization) (Germany) (No. 3) Order, 1948.
- 2. Notwithstanding anything contained in section 3 of the Law, any person who carries on in Cyprus the business of banking may, unless I otherwise direct, for the purpose of that business trade with any government, public or other authority within Germany or with any individual or body of persons (whether corporate or unincorporate) resident or carrying on business therein.

- 3. Notwithstanding anything contained in section 3 of the Law, any person may, unless I otherwise direct, trade with any individual or body of persons (whether corporate or unincorporate) carrying on the business of banking in Germany.
- 4. Nothing in this Order shall be taken to authorize the transmission to any person of any money, negotiable instrument or security for money arising out of any transaction entered into before the date of this Order.
 - 5. For the purposes of this Order "trade" shall include:-
 - (a) the carrying on of the business of banking,
 - (b) the entering into and completion of transactions incidental thereto with persons wheresoever resident, and
 - (c) except as provided in clause 4 hereof the paying, transmitting or receiving of any money, negotiable instrument or security for money.
- 6. For the purposes of this Order "Germany" means Berlin and the French, British, American and Russian Military Zones of Germany as established by the Statement by the Governments of the United Kingdom, the United States of America, the Union of Soviet Socialist Republics and the Provisional Government of the French Republic on the Zones of Occupation in Germany on the 5th June, 1945, and also those parts of the former German Reich which are at present administered by the Union of Soviet Socialist Republics.
- 7. This Order shall be deemed to have come into operation on the 23rd day of July, 1948.
