THE TREE PLANTING (VILLAGE AREAS) LAW, 1948.

ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Rizokarpaso in the District of Famagusta on the 4th July, 1948, it was determined by the requisite majority of the owners present that certain areas should be reserved as a Tree Planting Area of the said village of Rizokarpaso;

And whereas the Mukhtar of the same village of Rizokarpaso has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law:

Now, therefore, I, the Commissioner of the District of Famagusta, having approved the said reports, do by this order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting Area of the said village of Rizokarpaso.

SCHEDULE.

Area A.

The area lying within the following boundary that is to say:—

The boundary commences at the north-western corner of plot No. 44 of the Government Survey Plan No. I.52, locality "Lembos", which corner is on the seashore, and proceeds north-eastwards along the seashore to the most western point of plot No. 17 of the Government Survey Plan No. I.45, locality "Stilos"; thence south-eastwards along the boundaries of and including plots Nos. 10, 29, 45, 47, 69, 71, 110, 111 and 117 of the said plan to the south-western corner of the last mentioned plot, which corner is on the right bank of Ayios Thoros River; thence southwards along the right bank of the said river to the most western point of plot No. 140.1 of the Government Survey Plan No. I.46; thence north-eastwards along the boundary of and including the said plot to the most northern point of the said plot, which point is on the boundary of Khalasta Main State Forest; thence south-eastwards, north-westwards, south-eastwards and south-westwards along the said forest boundary; thence along the boundary of and including plot No. 427 of Government Survey Plan No. I.61, locality "Exolekko", to the most western point of the said plot, which point is at a junction of roads; thence north-westwards along the boundaries of and including plots Nos. 426, 340, 335, 334, 268, 249, 266, 178, 55, 53, 57, 59, 60 and 38 of the said plan, plot Nos. 262, locality "Latsia", 261, 229, 231, 190, 187, 163, 118, 117, 116, 168, 174, 173 and 172 of the Government Survey Plan No. I.53, plots Nos. 126, 125, 124, 123, 132, 122, 135, 120, 139, 140, 151, 152, 154, 44, 111, 155, 156, 157 and 165 of the Government Survey Plan No. I.52, to the Forest Cairn No. 3, which cairn is on the boundary of Eleousa Main State Forest; thence north-eastwards and north-westwards along the said forest

boundary to the most eastern point of plot No. 60 of the said plan, locality "Skona"; thence north-westwards along the boundaries of and including plots Nos. 60, 59, 58, 53, 2 and 44 of the said plan, to the point of commencement. All which said boundary is shown edged in red on the Government Survey Plan Serial No. 1437 and surrounds an area of 8,051 donums or thereabouts.

Area B.

The area lying within the following boundary, that is to say:—

The boundary commences at the north-western point of plot No. 42 of the Government Survey Plan No. IV.3, locality "Mantzis", and proceeds eastwards, north-eastwards and southwards along the boundaries of and including plots Nos. 42, 41, 50 and 52 of the said plan, plot No. 682 of the Government Survey Plan No. IV.4, plots Nos. 24 and 23 of the Government Survey Plan No. IV.3, plots Nos. 555, 554, 553, 393, 392, 391, 395, 390, 205, 204, 212, locality "Potamiá", 211, 206, 208, 388, 395, 550, 566, 565, 564, 563, 679, locality "Mantzis", 684 and 768 of the said plan, locality "Katsikas", plots Nos. 7 and 9 of the Government Survey Plan No. IV.12, plot No. 770 of the Government Survey Plan No. IV.4, plots Nos. 13, 16, 18, 48, 45 and 21 of the Government Survey Plan No. IV.12, locality "Melissonas", plots Nos. 38, 22, 23, 24, 25 and 34 of the Government Survey Plan No. IV.12, to the north-western corner of the last mentioned plot, which corner is on the road leading from the village of Galinoporni to the village of Rizokarpaso; thence north-eastwards along the said road to its junction with another road, which junction is at the most northern point of plot No. 747 of the Government Survey Plan No. IV.4; locality "Mandres"; thence north-eastwards along the boundaries of and including plots Nos. 747, 749 of the said plan, plot No. 30 of the Government Survey Plan No. IV.12, plots Nos. 730, 745, 744, 740 and 739 of the Government Survey Plan No. IV.4, plot Nos. 5, 10, 6, 428, 345, 347, 350, 325, 324, 322, 321, 290, 291, 262, 234, 233, 236, 79, 78, 64, 65 of the Government Survey Plan No. IV.5, plots Nos. 470, 471 and 473 of the Government Survey Plan No. I.61, to the north-eastern corner of the last mentioned plot, which corner is on the boundary of the Khalasta Main State Forest; thence southwards, north-eastwards and south-eastwards along the said forest boundary to the seashore; thence southwards along the seashore to the boundary of the Melissakros Minor State Forest; thence south-westwards along the said forest boundary and through the Forest Cairn No. 1, to the south-western corner of plot No. 209 of the Government Survey Plan No. IV.21; thence northwards and south-westwards along the boundaries of and including plots Nos. 209, 200.6, 1,200.6, and 198 of the said plan, plots Nos. 363, 332, 294, 279, 267, 246, 231, 250, 229, 211, 212, 228, 214, 251, 252, 265, 283, 284, 285, 289, 288, 287, 260, 259, 27, 34, 28 and 29 of the Government Survey Plan No. IV.13, plot No. 125 of the Government Survey Plan No. IV.12, plot No. 30 of the Government Survey Plan No. IV.13, plots Nos. 168, 169, 170, 183 and 182 of the Government Survey Plan No. IV.12, to the south-western corner of the last mentioned plot, locality "Findikia", which point is on a ridge; thence southwards and westwards along the said ridge to the Forest Cairn No. 41, which cairn is on the boundary of the Karpas Main State Forest; thence north-westwards, westwards and north-westwards along the said forest boundary to Forest Cairn No. 34, which cairn is at the south-western corner of plot No. 50 of the Government Survey Plan No. IV.3; thence northwards along the boundaries of and including plots Nos. 50 and 42 of the said plan to the point of commencement. All which said boundary is shown edged in red on the Government Survey Plan Serial No. 1437 and surrounds an area of 7,417 donums or thereabouts.

Area C.

The area lying within the following boundary, that is to say:—

The boundary commences at the north-eastern corner of plot No. 431 of the Government Survey Plan No. I.60, which point is on the Nicosia-Rizokarpaso main road, and proceeds south-eastwards along the said road to its junction with another road, which junction is at the north-western corner of plot No. 447 of the said plan; thence south-eastwards along the last mentioned road to the south-eastern corner of plot No. 533 of the said plan; thence westwards, southwards and north-westwards along the boundaries of and including plots Nos. 533, 534, 535 and 576.1 of the said plan, plots Nos. 8, 5, 4, 2 and 1 of the Government Survey Plan No. IV.4, plots Nos. 543, 539, 538, 435, 432, 437, 438, 439 and 431 of the Government Survey Plan No. I.60, to the point of commencement. All which said boundary is shown edged in red on the Government Survey Plan Serial No. 1437 and surrounds an area of 359 donums or thereabouts.
