

## No. 192. THE DANGEROUS DRUGS LAWS, 1925 TO 1932.

## ORDER MADE UNDER SECTION 13.

In exercise of the powers conferred on me by section 13 of the Dangerous Drugs Laws, 1925 to 1932, I, the Acting Governor, do hereby order as follows:—

1. The persons whose names appear in the Schedule hereto are hereby authorized to exercise, within the area or district appearing against the name of each such person in the third column of the said Schedule, all the powers conferred upon persons so authorized by section 13 of the said Laws.

2. The Order dated the 28th July, 1943, published under Notification No. 270 in Supplement No. 3 to the *Gazette* of the 5th August, 1943, is hereby revoked without prejudice to anything done thereunder.

## THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1948.

## ORDER MADE BY THE ACTING GOVERNOR UNDER SECTION 207 (1).

In exercise of the powers vested in me by section 207 (1) of the Municipal Corporations Laws, 1930 to 1948, I, the Acting Governor, do hereby order as follows:—

1. This Order may be cited as the Municipal Elections (Closing of Licensed Premises) (Town Municipalities) Order, 1949.

2. In this Order—

“licensed premises” means any premises licensed for the sale of intoxicating liquors by retail under the provisions of the Sale of Intoxicating Liquors Law, 1943.

3. Notwithstanding anything contained in the Sale of Intoxicating Liquors (Retailers Closing Hours) Orders, 1945 and 1949, all licensed premises situated within the limits of the Municipal Corporations specified in the first column to the Schedule hereto shall, during the dates and hours specified in the second column of the said Schedule, be closed and remain closed.
