## THE TREE PLANTING (VILLAGE AREAS) LAW, 1948.

## ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Kalavastos in the District of Larnaca on the 12th December, 1948, it was determined by the requisite majority of the owners present that certain areas should be reserved as a Tree Planting Area of the said village of Kalavastos;

And whereas the Mukhtar of the same village of Kalavastos has forwarded to me a report signed and sealed by him containing a description of the areas in question with boundaries and particulars and stating that such areas fulfil the conditions prescribed in section 10 (4) of the said Law:

Now, therefore, I, the Commissioner of the District of Larnaca having approved the said reports, do by this Order declare that the areas described in the Schedule hereto shall be reserved as the Tree Planting area of the village of Kalavastos.

## SCHEDULE.

## (Area A.)

The area lying within the following boundary, that is to say:—

The boundary commences at the north-western corner of plot No. 344 of the Government Survey Plan No. XLIX.59, locality "Kafkala", and proceeds south-eastwards along the boundaries of and including plot No. 344 of the said plan, plots Nos. 198, 199, 201 and 202 of the Government Survey Plan No. LV.3, to the south-eastern corner of the last mentioned plot, which corner is on the Vasilikos River; thence eastwards along the left bank of the said river to the north-western corner of plot No. 208 of the said plan; thence eastwards and southwards along the boundaries of and including plots Nos. 208, 205, 207, 212, 217 and 218 of the said plan, locality "Potima", plots Nos. 38, 44, 37, 45, 87, 101, 126, 150, 145, 144 and 143 of the Government Survey Plan No. LV.4, to the south-western corner of the last mentioned plot; thence westwards and north-westwards (across the Vasilikos River) along the boundaries of and including plots Nos. 142, 141, 138, 224 and 137 of the said plan, plots Nos. 340, 253, 254, 295, 297, 292, 299, 301, 302, 285, 279, 193, 194 (across the Vasilikos River), 197, 199, 198, of the Government Survey Plan No. LV.3 and plot No. 344 of Government Survey Plan No. XLIX.59, to the point of commencement. All which said boundary is shown edged red on the Government Survey Plan, Serial No. 1444, and surrounds an area of 462 donums or thereabouts.

## (Area B.)

The boundary commences at the most northern point of plot No. 208 of the Government Survey Plan No. LV.12, locality "Mazeri", and proceeds north-eastwards and south-eastwards along the boundaries of and including plots Nos. 208, 218, 219, 274, 338 and 339 of the said plan, plots Nos. 44, 47, 50, 53, 54, 55, 61, 62, 73, 73, 71, 236 and 237 of the Government Survey Plan No. LV.20, plots Nos. 5, 7 and 8 of the Government Survey Plan No. LV.21, to the north-eastern corner of the last mentioned plot, which corner is on the Nicosia-Limassol main road; thence south-westwards and north-westwards along the said main road to the south-western corner of plot No. 421 of the Government Survey Plan No. LV.20, locality "Ayios Dhimitrios"; thence northwards along the boundaries of and including plots Nos. 421, 405, 404, 338, 340, 334, 289, 279, 280, 275, 192, 193, 194, 188, 130, 206, 136, 19, 20 and 22 of the said plan, locality "Kokkinos Kremmos", plots Nos. 325, 331, 330, 329, 268, 269, 244 (across the Vasilikos River), 239, 238, 237, 240 and 208 of Government Survey Plan No. LV.12, to the point of commencement. All which said boundary is shown edged in red on the Government Survey Plan, Serial No. 1444, and surrounds an area of 1,686 donums or thereabouts.
