SUBSIDIARY LEGISLATION.

No. 240. BY THE ACTING GOVERNOR.

A PROCLAMATION.

Whereas within the area of the village of Spilia in the District of Nicosia there is a settlement known as "Kourdhali";

And whereas it is expedient that the area of the said village should be divided so that two quarters be formed:

Now, therefore, in exercise of the powers vested in me by section 17 of the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, I, Roland Evelyn Turnbull, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby order and proclaim that from and after the 1st day of August, 1949:—

- (a) the said settlement "Kourdhali" comprised within the boundaries set out in Schedule A hereto shall be and is hereby constituted a quarter of the village of Spilia and shall, for all administrative purposes, be ranked as a separate quarter of the said village under the style of Kourdhali quarter; and
- (b) the remaining area of the said village comprised within the boundaries set out in Schedule B hereto shall be and is hereby constituted a quarter of the said village and shall, for all administrative purposes, be ranked as a separate quarter of the said village under the style of Ayios Antonios quarter.

SCHEDULE A.

Boundary of Kourdiali Quarter of Spilia Village.

The boundary commences at the north-western corner of plot No. 4 of the Government Survey Plan No. XXXVII.14, locality "Dhimma", which point is on the boundary between the villages of Spilia and Ayios Theodoros and proceeds north-eastwards and south-eastwards along the said village boundary to the north-eastern corner of plot No. 3 of the Government Survey Plan No. XXXVII.23, which corner is on the boundary between the villages of Spilia and Ayia Irini; thence south-eastwards along the said village boundary to the south-eastern corner of plot No. 476.1 of the Government Survey Plan No. XXXVII.31, locality "Pervoloudhia"; thence westwards along the boundaries of and including the last mentioned plot, locality "Angatheri", plots Nos. 108, 109, 104, 102, 331, 332, 120, 125 and 154 of the said plan, to the Forest Cairn No. 1006, which cairn is on the boundary of the Adelphi Main State Forest, locality "Xylambela"; thence north-westwards and westwards along the said forest boundary to the most eastern corner of plot No. 248.2 of the Government Survey Plan No. XXXVII.30; thence south-westwards along the boundary of and including the last mentioned plot to the north-western corner of plot No. 248.1 of the said plan, locality "Exo Moni", which point is on the boundary between the villages of Spilia and Kakopetria; thence north-westwards along the said village boundary to the point of commencement, all which said boundary is shown edged red on the Government Survey Plan Serial No. 1440.

SCHEDULE B.

Boundary of Ayios Antonios Quarter of Spilia Village.

The boundary commences at the north-western corner of plot No. 248.1, of the Government Survey Plan No. XXXVII.30, locality "Exo Moni", and proceeds eastwards along the boundary of and including the said plot to the Forest Cairn No. 991, which cairn is on the boundary of the Adelphi Main State Forest; thence eastwards along the said forest boundary to the north-eastern corner of plot No. 186 of the Government Survey Plan No. XXXVII.31, locality "Xylambela"; thence eastwards along the boundaries of and including plots Nos. 185, 155, 119, 118, 116, 115, 337, 333, 334, 114.1, 103, 114.2, 113.2, 110, 454, 457, 470.3, 470.2, 470.1 and 476.2 of the said plan, to the north-eastern corner of the last-mentioned plot, locality "Petromuti"; which corner is on the boundary between the villages of Spilia and Ayia Irini; thence south-eastwards along the said village boundary to the most southern point of plot No. 477 of the said plan, locality "Mutalli-tis-Eleas", which point is on the boundary between the villages of Spilia and Kannavia; thence westwards and south-westwards along the said village boundary to the south-eastern corner of plot No. 553, of the Government Survey Plan No. XXXVII.39, locality "Levteroudhia", which corner is on the boundary between the districts of Nicosia and Limassol; thence westwards and south-westwards along the said district boundary to its junction with the boundary between the villages of Spilia and Kakopetria, locality "Karvounas"; thence northwards and north-eastwards along the said village boundary to the point of commencement, all which said boundary is shown edged yellow on the Government Survey Plan Serial No. 1440.
