THE SUMMER RESORTS (DEVELOPMENT) LAWS, 1938 AND 1946.

ORDER IN COUNCIL No. 2365 MADE UNDER SECTION 25 (a) (i).

Authority to the Summer Resort Development Board of Platres to contract two loans.

In exercise of the powers vested in me by section 25 (a) (i) of the Summer Resorts (Development) Laws, 1938 and 1946, I, the Acting Governor, with the advice of the Executive Council, do hereby order as follows:—

- 1. That the Summer Resort Development Board of Platres (hereinafter referred to as "the Board") shall be at liberty to borrow from the Government of Cyprus (hereinafter referred to as "the Government")—
 - (1) a sum not exceeding ten thousand pounds (£10,000) at a rate of interest not exceeding three and one-quarter per centum $(3\frac{1}{4}\%)$ per annum; and
 - (2) a sum not exceeding twenty-one thousand pounds (£21,000) at a rate of interest not exceeding four per centum (4%) per annum.

subject to the following terms and conditions, that is to say :-

- (a) that both sums borrowed shall be repayable by the Board to the Government in not more than thirty equal annual instalments (comprising sinking fund and interest);
- (b) that the sum of ten thousand pounds mentioned in 1 (1) above 'shall be utilized by the Board for the following purposes, that is to say:—
 - (i) for purchasing two lorries (a cesspit emptier
 - and a combined refuse carrier and road sprayer) £3,000 (ii) for improvements to water supply ... £3,000
 - (iii) for providing car parks and constructing lairage and petroleum stores £3,000
- (iv) for constructing public lavatories ... £1,000 (c) that the sum of twenty-one thousand pounds mentioned in 1 (2)
- (c) that the sum of twenty-one thousand pounds mentioned in 1 (2) above shall be utilized by the Board for the following purposes, that is to say:—
 - (i) for reconstructing the Power Station;
 - (ii) for providing a new distribution net-work; and

(iii) for purchasing a new generating plant;

(d) that when the Grid Scheme comes into operation, the Board shall obtain its electric supply from, and operate its own plant in conformity with the directions of, the Authority responsible for the all-Island supply.

2. That for the purpose of securing the repayment of the said sums of ten thousand pounds and twenty-one thousand pounds the Board shall, subject to any prior mortgage thereon, mortgage to the Government all the properties of the Board and all the rates, fees and duties now payable or hereafter to become payable to the Board.

No. 254. THE FORESHORE PROTECTION LAW, 1934.

REVOKED:

NOTICE UNDER SECTION 5 (1).

In exercise of the powers vested in me by section 3 (1) of the Foreshore Protection Law, 1934, I hereby absolutely prohibit:

(a) the removal of stones, shingle, gravel, sand or other substance from all that area of foreshore described in the Schedule hereto;

(b) the dumping of any rubble, rubbish, sweepings, litter, night-soil or other refuse upon any part of the foreshore described in the Schedule hereto.

SCHEDULE.

Karavas Village.

The foreshore commences at the mouth of the river Mavrolimni (Government Survey Plan X1.16.W) and proceeds north-eastwards and south-eastwards to the north-east of Plot Nos. 57/2 and 58 on the Village Boundary line of Karavas and Ayios Yeoryios and almost opposite to the Milepost 4 (Government Survey Plan X11.10.E) as shewn delineated in yellow on Government Survey Plan deposited in the Office of the Commissioner, Kyrenia. The foreshore includes all land within a distance of 50 yards from the high water mark throughout its length.

No. 255. THE BURIALS LAWS, 1896 AND 1937.
