### THE TREATY OF PEACE (BULGARIA) ORDER, 1948.

#### VESTING ORDER.

### A. B. WRIGHT,

Governor.

In exercise of the powers vested in me by the Treaty of Peace (Bulgaria) Order, 1948, and of all other powers enabling me in that behalf, I, the Governor, do hereby make the following Order :---

1. This Order may be cited as the Treaty of Peace (Bulgaria) Vesting Order, 1949.

2. There shall vest in the Administrator appointed pursuant to the terms of the said Order the following property, rights or interests subject to the charge imposed by the said Order, namely :---

All property, rights or interests existing by virtue of any will, settlement or other trust or by virtue of any contract or agreement of any kind whatsoever, including the right to receive, recover and be paid any moneys payable presently or at any future time in respect of any such trust, will, settlement, contract or agreement : Provided nevertheless that if the vesting to be effected by this Order would cause a forfeiture or determination of any such property, right or interest as aforesaid, then in any such case this Order shall not have the effect of vesting the same in the said Administrator, and provided also that there shall be excepted from the vesting to be effected by this Order—

(a) any estate or interest in land; and

(b) the property, rights and interests within the Colony belonging to or held or managed on behalf of any individual of Bulgarian Nationality resident in territory which has at no time been Enemy Territory as defined by the Trading with the Enemy Laws, 1939 to 1945, other than property, rights or interests which have been subject to an Order made by the Governor under section 9 of the Trading with the Enemy Laws, 1939 to 1945.

3. The said Administrator shall have the following rights and powers with regard to the said property, rights and interests, namely :---

- (a) To sell or otherwise dispose of and to transfer any such property, rights or interests as aforesaid.
- (b) To give a receipt for and an effective discharge for any moneys payable as aforesaid or any other property transferable by virtue of any such will, settlement, trust, contract or agreement as aforesaid.
- (c) To recover and sue for any such moneys or property as aforesaid and to enforce any such trust (whether existing by virtue of any will or settlement or otherwise) or any such contract or agreement as aforesaid and any rights relating thereto and for that purpose to begin and prosecute or discontinue legal proceedings and to instruct counsel.
- (d) To compromise any matter and to accept any composition or any payment or transfer on account.
- (e) To employ and pay such agents as the said Administrator shall think fit to employ.
- (f) To sign, seal and deliver and execute any deed or other document in connection with any such matters as aforesaid.
- (g) To raise and pay the amount of any expenses out of any such moneys or property as aforesaid.

(h) Generally to do any act or thing that may be necessary or proper for reducing to possession, recovering or protecting any of such property, rights and interests and moneys as aforesaid or for enforcing or making effective and complete the vesting effected by this Order and carrying out the powers, rights and duties of the said Administrator in connection with the same.

# THE TREATY OF PEACE (HUNGARY) ORDER, 1948.

#### VESTING ORDER.

A. B. WRIGHT,

Governor.

In exercise of the powers vested in me by the Treaty of Peace (Hungary) Order, 1948, and of all other powers enabling me in that behalf, I, the Governor, do hereby make the following Order:—

1. This Order may be cited as the Treaty of Peace (Hungary) Vesting Order, 1949.

2. There shall vest in the Administrator appointed pursuant to the terms of the said Order the following property, rights or interests subject to the charge imposed by the said Order, namely:—

All property, rights or interests existing by virtue of any will, settlement or other trust or by virtue of any contract or agreement of any kind whatsoever, including the right to receive, recover and be paid any moneys payable presently or at any future time in respect of any such trust, will, settlement, contract or agreement : Provided nevertheless that if the vesting to be effected by this Order would cause a forfeiture or determination of any such property, right or interest as aforesaid, then in any such case this Order shall not have the effect of vesting the same in the said Administrator, and provided also that there shall be excepted from the vesting to be effected by this Order—

(a) any estate or interest in land; and

(b) the property, rights and interests within the Colony belonging to or held or managed on behalf of any individual of Hungarian Nationality resident in territory which has at no time been Enemy Territory as defined by the Trading with the Enemy Laws, 1939 to 1945, other than property, rights or interests which have been subject to an Order made by the Governor under section 9 of the Trading with the Enemy Laws, 1939 to 1945.

3. The said Administrator shall have the following rights and powers with regard to the said property, rights and interests, namely :---

- (a) To sell or otherwise dispose of and to transfer any such property, rights or interests as aforesaid.
- (b) To give a receipt for and an effective discharge for any moneys payable as aforesaid or any other property transferable by virtue of any such will, settlement, trust, contract or agreement as aforesaid.
