THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

The following rules made by the Village Health Commission of Panayia, in the District of Paphos, and approved by the Commissioner, are published in the *Gazette*.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF PANAYIA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Panayia hereby make the following rules :---

1. These rules may be cited as the Village Health (Panayia) (Amendment) Rules, 1949, and shall be read as one with the Village Health (Panayia) Rules, 1938 and 1940 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Panayia) Rules, 1938 and 1949.

2. The following rules shall be substituted for rules 20, 32, 46, 54 and 57, respectively, of the principal Rules :---
