THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

The following rules made by the Village Health Commission of Kilani, in the District of Limassol, and approved by the Commissioner, are published in the Gazette.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF KILANI UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Kilani hereby make the following rules :---

1. These rules may be cited as the Village Health (Kilani) (Amendment) Rules, 1949, and shall be read as one with the Village Health (Kilani) Rules, 1938 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Kilani) Rules, 1938 and 1949.

2. The following rules shall be substituted for rules 20, 46 and 54, respectively, of the principal Rules :---

"Rule 20.—The following fees shall be paid by the owner of or the person slaughtering any animal in the slaughter-house, that is to say :---

(2) The fees in paragraph (1) of this rule prescribed shall not be payable by any person exposing any fresh meat in the meat market, who is a monthly or yearly lessee of any shop, stall or place in the meat market under rule 45 of these Rules.
