" permit" means a written permit issued under the provisions of this Order either by the Vine Products Controller or by any person

Save under a permit, no person shall, after the appointed day, to an authorized purchaser.

7. Save under a permit, no person, other than an authorized purchaser,

shall, after the appointed day, purchase any zivania:

Provided that any person may purchase by retail from any dealer by retail any zivania reasonably required for use or consumption in the purchaser's household for a reasonable time.

- 8. No person who is not a manufacturer, a producer, an authorized purchaser, or the holder of a permit shall, after the appointed day, have in his possession or under his control any zivania in excess of ten okes.
- 9. The Vine Products Controller or any other person authorized by him in that behalf may-
  - (a) attach such terms or conditions as he may think fit to any permit, and the holder of any such permit shall comply with all such terms and conditions;
  - (b) revoke any such permit.
- 10. Every person shall permit such person as the Vine Products Controller or the Commissioner of the District may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.

11. Any person who—

(a) acts in contravention of or fails to comply with any of the provisions of this Order;

(c) makes, under any of the provisions of this Order, any return which is false in any material particular;
