## THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

The following rules made by the Village Health Commission of Perapedhi, in the District of Limassol, and approved by the Commissioner, are published in the *Gazette*.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF PERAPEDHI  
UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Perapedhi hereby make the following rules:—

1. These rules may be cited as the Village Health (Perapedhi) (Amendment) Rules, 1949, and shall be read as one with the Village Health (Perapedhi) Rules, 1938 and 1945 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Perapedhi) Rules, 1938 to 1949.

2. The following rule shall be substituted for rule 32 of the principal Rules:—

"Rule 32.—There shall be paid by every person exposing for sale any perishable goods in the market of perishable goods a fee of one para per oke."

## THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

The following rules made by the Village Health Commission of Pyrgos, in the District of Limassol, and approved by the Commissioner, are published in the *Gazette*.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF PYRGOS  
UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Pyrgos hereby make the following rules which shall be deemed to have come into operation on the 30th May, 1948:—

1. These rules may be cited as the Village Health (Pyrgos) (Amendment) Rules, 1949, and shall be read as one with the Village Health (Pyrgos) Rules, 1938 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Pyrgos) Rules, 1938 and 1949.

2. The following rule shall be substituted for rule 46 of the principal Rules:—

"Rule 46.—(1) The following fees shall be paid by every person exposing for sale any fresh meat in the meat market, that is to say:—

(a) For every carcass of sheep, lamb, goat or kid or part thereof .. .. .	1	0
(b) For every carcass of swine, ox, camel, cow or bullock or part thereof .. .. .	1	4½

(2) The fees in paragraph (1) of this rule prescribed shall not be payable by any person exposing any fresh meat in the meat market, who is a monthly or yearly lessee of any shop, stall or place in the meat market under rule 45 of these Rules."
