No. 421. THE LAND ACQUISITION LAWS, 1899 TO 1947.

NOTICE UNDER SECTION 5.

With reference to the Notification published under No. 362 in Supplement No. 3 to *Gazette* No. 3460 of the 29th September, 1949, notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned therein:—

All that area of land situated at Strovolos, in the District of Nicosia, at the locality "Perneris", comprising 6 donums, 2 evleks and 800 sq. ft. or thereabouts bounded by private property and Crown land, and including plot No. 56 of Block "J", Strovolos, belonging to Costas Savva Hj. Yanni Kourea, of Nicosia, Christodoulos, Adelphothea (or Lefkou), Anna Savva Hj. Yanni Kourea, of Strovolos, and Nicolas and Yangos Savva Hj. Yanni Kourea of unknown residence, and plot No. 57B of Block "J", Strovolos, belonging to Loizos Petrou Voniatis, of Strovolos.

These lands are more particularly defined as the areas coloured green and brown on the plan marked "Reservoir site for the Nicosia Water Supply" dated 6th October, 1949, deposited with the Commissioner of Nicosia.

**THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES
LAW, 1948.**

(SECTION 12 (2).)

Notice is hereby given that the immovable property, as hereinafter, is required by the Water Commission of Yermasoyia, in connection with a scheme for the supply and maintenance of a supply of water for the domestic purposes of the inhabitants of the said village under the provisions of the Water (Domestic Purposes) Village Supplies Law, 1948.

Any person claiming to have any right or interest in the immovable property to which this notice relates, who objects to the acquisition of any such property, is required within six weeks from the date of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

The Water Commission of Yermasoyia is willing to treat for the acquisition of the immovable property to which this notice relates.

The immovable property to which this notice relates is as follows (a plan showing the same being available for inspection during a period of six weeks from the date of this notice at my Office at Limassol from 9 a.m. to 12 noon daily, except on Sundays and holidays):—

- (a) A spring known as "Pano Fountana", a field and one carob tree standing on plot No. 87/2 of Sheet Plan LIV.34 of Yermasoyia.
- (b) A spring known as "Kato Fountana", a field, one carob tree and one reservoir (16 × 9½ × 6) standing on plot No. 28.1 near plot 7 of Sheet Plan LIV.35 of Yermasoyia.
- (c) A spring known as "Latchi", a field and one carob tree standing on plot No. 26/2 of Sheet Plan LIV.35 of Yermasoyia.
