

SCHEDULE.

The area lying within the following boundaries, that is to say:—
 The boundary commences at the most northern point of plot No. 92 of the Government Survey Plan No. XXVIII. 27, locality "Koutsoulla", which point is on the village boundary between the villages of Lefka and Kalopanayiotis, and proceeds south-eastwards, north-eastwards and southwards along the said village boundary to its junction with the village boundary between the villages of Katydhata and Kalopanayiotis, locality "Mahmoudoudhia"; thence southwards along the last mentioned village boundary to the Forest Cairn No. 867 of the Troodos Main State Forest, which cairn is at the south-eastern corner of plot No. 29 of the Government Survey Plan No. XXVIII. 35, locality "Pyrgolophos"; thence southwards along the said forest boundary and through the Forest Cairns Nos. 866, 865, 864, 863 and 862 of the said plan, Forest Cairns Nos. 861, 860, 859, 858, 857, 856, 855, 854, 853, 852, 851 and 850 to the Forest Cairn No. 849 of the Government Survey Plan No. XXVIII. 43, which cairn is at the most southern point of plot No. 16 of the said plan, locality "Muti tou Khaloupiti"; thence north-westwards along the boundaries of and including plots Nos. 16, 17 and 6 of the said plan, plots Nos. 23, 25, 24 and 23 of the Government Survey Plan No. XXVIII. 35, Plots Nos. 82, 81, 80, 66, 64, 62, 52, 45, 44 and 38 of the Government Survey Plan No. XXVIII. 34, to the south-eastern corner of the last mentioned plot, which corner is on the Marathasa River, locality "Periphanena"; thence southwards along the left bank of the said river to the south-eastern corner of plot No. 34 of the said plan; thence westwards along the boundary of and including the said plot, across the Lefka-Kalopanayiotis main road, to the Forest Cairn No. 1030 of Paphos Main State Forest, which cairn is at the most southern point of plot No. 32 of the said plan; thence north-westwards and south-eastwards along the said forest boundary and through the Forest Cairns Nos. 1029, 1028, 1027, 1026, 1025, 1024, 1023, 1022 to 1021 of the said plan, which last mentioned cairn is on the western side of Lefka-Kalopanayiotis main road; thence eastwards across the said main road; thence northwards along the eastern side of the said main road to the north-western corner of plot No. 77 of the said plan, locality "Ayios Mamas", which corner is on the village boundary between the villages of Lefka and Kalopanayiotis; thence northwards along the said village boundary to the point of commencement. All which said area is 3,397 donums or thereabouts, as shown edged in red on the Government Survey Plan Serial No. 1417.

THE TREE PLANTING (VILLAGE AREAS) LAW, 1948.

ORDER MADE UNDER SECTION 12.

Whereas at a meeting duly convened and held at the village of Livadhia in the District of Larnaca on the 18th July, 1948, under the provisions of the Tree Planting (Village Areas) Law, 1948, it was determined by the requisite majority of the owners present thereat that a certain area should be reserved as the Tree Planting Area of the said village of Livadhia;

And whereas the Mukhtar of the said village of Livadhia has forwarded to me a report signed and sealed by him containing a description of the area in question with boundaries and particulars and stating that such area fulfils the conditions prescribed in section 10 (4) of the said Law;

Now, therefore, I, the Commissioner of the District of Larnaca, having approved of the said report, do by this order declare that the area described in the Schedule hereto shall be reserved as the Tree Planting Area of the said village of Livadhia.

SCHEDULE.

The area lying within the following boundaries, that is to say:—
The boundary commences at the most southern point of plot No. 189 of the Government Survey Plan No. XL/32, locality "Kalunjis", which point is at the junction of the boundaries of the villages of Aradhippon, Kellia and Livadhia, and proceeds north-eastwards along the boundary of the village of Livadhia to the south-western corner of plot No. 247 of the Government Survey Plan No. XLI/25, locality "Kurkes", which point is on the road leading from Livadhia village to Vorokini village; thence southwards along the said road to the south-eastern corner of plot No. 66 of the said plan; thence north-westwards and south-westwards along the boundaries of and including plots Nos. 66, 64, 45, 46, 49, 50, 51, 52, 30 and 54 of the said plan, plots Nos. 429, 431, 433, 434 and 412 of the Government Survey Plan No. XL/32, locality "Kambos", plots Nos. 269, 267, 266, 265 and 264 of the Government Survey Plan No. XL/40, plot No. 388 of the Government Survey Plan No. XL/32, plots Nos. 259 and 258 of the Government Survey Plan No. XL/40, plot No. 384 of the Government Survey Plan No. XL/32, plot No. 256 of the Government Survey Plan No. XL/40, plot No. 438 of the Government Survey Plan No. XL/32, plots Nos. 253, 292, 294, 296, 297, 298, 299, 305, 304 and 303 of the Government Survey Plan No. XL/40, to the most northern point of plot No. 306 of the said plan, which point is on the boundary of the village of Livadhia; thence northwards along the said village boundary to the point of commencement. All which said area is 1,421 donums or thereabouts, as shown edged in red on the Government Survey Plan Serial No. 1420.

ORDER MADE UNDER SECTION 20.

In exercise of the powers vested in me by section 20 of the Tree Planting (Village Areas) Law, 1948, I do hereby order that the Order relating to the Tree Planting Area of the village of Ayios Photios, published in the *Gazette* of the 16th February, 1934, under Notification No. 230, and extended for a further period of five years from the expiration thereof by Notification No. 61 published in Supplement No. 3 to the *Gazette* of the 24th February, 1944, be extended for a further period of five years from the date of the expiration of the extended period thereof.
