THE INCREASE OF RENT (RESTRICTION) LAWS, 1942 TO 1947.

Notification under Section 4.

A. B. WRIGHT, Governor.

In exercise of the powers vested in me by section 4 of the Increase of Rent (Restriction) Laws, 1942 to 1947, and of every other power thereunto enabling, I, the Governor, do hereby order that the Notification No. 257 published in Supplement No. 3 to the Gazette of the 4th September, 1947, be amended as follows:-

- (a) By the deletion of the proviso to sub-paragraph (b) of the first paragraph thereof;
- (b) By the deletion from the second column of the Schedule thereto of all the names of the persons appearing therein as constituting the Rent Assessment Boards for the Rent Restriction Areas of Famagusta, Kyrenia, Larnaca, Limassol, Nicosia and Paphos, and the substitution therefor of the names of persons and the holders for the time being of the offices appearing in the second column of the Schedule hereto (including any officer appointed to act in such offices) in respect of each of the said Rent Restriction Areas, respectively, as shown in the first column of the Schedule hereto.

2. This notification shall come into effect on the 1st day of January, 1950.

No. 486. THE LAND ACQUISITION LAWS, 1899 TO 1947.

NOTIFICATION UNDER SECTION 6.

I, the Governor, in exercise of the powers vested in me by section 6 of the Land Acquisition Laws, 1899 to 1947, and with reference to the Notification dated the 28th day of June, 1947, and published under No. 186 in Supplement No. 3 to the Gasette of the 3rd of July, 1947, relating to the erection within the District of Larnaca of a power station, offices, workmen's quarters and such other erections or structures as from time to time may be considered necessary in connection with a scheme for the generation and supply of electricity in Cyprus and with reference to the Notification dated the 18th day of July, 1949, and published under No. 276 in Supplement No. 3 to the Gasette of the 21st of July, 1949, do hereby sanction, in addition to any previous acquisition, the acquisition under the provisions of the aforesaid Laws of the immovable properties situated in the village of Ormidhia in the District of Larnaca, particulars whereof are specifically set out in the notice of the Commissioner of Larnaca published under No. 369 in Supplement No. 3 to the Gasette of the 29th September, 1949, to vest and be registered in the name of the Government.
