

No. 487. THE ELEMENTARY EDUCATION LAWS, 1933 TO 1949.

NOTICE UNDER SECTION 73 (1).

It is hereby notified that in exercise of the powers vested in him by section 73 (1) of the Elementary Education Laws, 1933 to 1949, and otherwise, His Excellency the Governor is pleased to direct and hereby directs that the additional tax mentioned in section 65 of the said Laws payable by the Mohammedan taxpayers of the towns and villages mentioned in the Schedule hereto shall be increased by the rate per thousand shown opposite the name of each town or village to provide the amount required for the payment of loans or annual maintenance of the Moslem Schools of the said towns and villages, respectively.
