**No. 493. THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 TO 1949.**

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 to 1949, the following rules made by the Committee of the Irrigation Division of Psematismenos, in the District of Larnaca, are published in the *Gazette*.

**IRRIGATION DIVISION OF PSEMATISMENOS.****Rules.**

1. These rules may be cited as the Irrigation Division of Psematismenos Rules, 1949.
2. In these rules, unless the context otherwise requires—
  - "Commissioner" means the Commissioner of the District of Larnaca;
  - "Committee" means the Committee of the Irrigation Division;
  - "Irrigation Division" means the Irrigation Division of Psematismenos;
  - "Law" means the Irrigation Divisions (Villages) Laws, 1938 to 1949;
  - "list" means the list of the names and residence of the proprietors and of the lands and extent thereof which are to be benefited or are capable of being benefited by the works prepared under the provisions of section 15 of the Law as finally settled under the provisions of section 16 of the Law;
  - "works" means the irrigation works of the Irrigation Division.
3. The Committee shall hold office for a period of three years beginning on the 16th October, 1949. Thereafter the election of the Committee shall take place every third year in the first week of the month of October, and it shall hold office for a period of three years from the day next following its election.
