BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF LIMASSOL.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1948, and otherwise, the Council of the Municipal Corporation of Limassol hereby make the following bye-laws:-

1. These bye-laws may be cited as the Municipal Corporation (Limassol) (Amendment) Bye-laws, 1949, and shall be read as one with the Municipal Corporation (Limassol) Bye-laws, 1931 to 1948 (hereinafter Suppl. No. 3: referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Limassol) Bye-laws, 1931 to 1949.

2. Bye-law 56 of the principal Bye-laws is hereby deleted and the

following bye-law substituted therefor:-

"56. The shops, stalls and places situated in the Municipal market, which are now used for the sale of fresh pork, are hereby provided and shall henceforth be used as a public pork market."

3. The principal Bye-laws are hereby amended by the insertion

therein immediately after bye-law 60 of the following bye-law:-

"60A. The shops, stalls and places situated in the pork market may be let on hire by the Council for such period and on such terms and conditions as the Council may from time to time determine:

Provided there are other shops, stalls or places therein for the

sale of fresh pork by persons other than lessees."

4. Bye-law 61 of the principal Bye-laws is hereby amended by the addition thereto after paragraph (2) of the following paragraph:

"(3) The tolls in paragraph (1) of this bye-law prescribed, shall not be payable by any person exposing for sale any fresh pork in the pork market, who is a monthly or yearly lessee of any shop, stall or place in the pork market under by-law 60A of these bye-laws.

5. These bye-laws shall be deemed to have come into operation on

the 15th day of November, 1948.

The above bye-laws have been approved by His Excellency the Governor.

of the words " at the rate of one six hundredth of his salary ".

3. Paragraph (a) of bye-law 16 of the principal Bye-laws is hereby deleted and the following paragraph substituted therefor:-

4. These bye-laws shall be deemed to have come into operation on the 1st day of January, 1947.
