THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, I hereby order as follows:—

- 1. This Order may be cited as the Supplies and Services (Bakeries, Bread and Wheat Control) Order, 1949.
 - 2. In this Order, unless the context otherwise requires,—
 - "bakery" means any building, room or place used for or connected with the preparation, making or baking of bread for sale whether by retail or wholesale;
 - "bread" means household bread of any size or shape or rolls of any size or shape and includes what are commonly known as koullouria and paximadia;
 - "flour" means the product of wheat ground in the Colony;
 - "purchase" includes—
 - (a) any offer to purchase,
 - (b) any attempt to purchase,
 - (c) any arrangement to purchase made either directly or indirectly;

Gazettes: Suppl. No. 3: 3. 1.1946 28. 3.1946 "registered baker" means any person registered as a baker under this Order and includes any person registered as a baker, or deemed to be a registered baker, under the Defence (Bakeries and Bread Control) Orders, 1946;

- "sale" and "sell" include— ·
 - (a) any offer to sell,
 - (b) any attempt to sell,
 - (c) any arrangement to sell made either directly or indirectly;
- "wheat flour" means the ground product of wheat with no more than 10% of the bran having been extracted therefrom and free from any other cereals, foreign matter or added bran.
- 3. No person shall keep or work a bakery unless such person is a registered baker.
- 4.—(1) Any person desiring to be registered under this Order as a registered baker shall complete and deliver to me an application specifying the place at which the bakery which he intends to keep or work is situated.
- (2) Upon receipt of an application as in sub-clause (1) hereof provided I may register the applicant as a registered baker and thereupon a certificate of registration shall be issued to him under my hand or under the hand of any person authorized by me in writing in that behalf.

5. Any certificate of registration issued to a registered baker may at any time be cancelled by me:

Provided that any person aggrieved by my decision may, within seven days from the date of the notification of such decision, appeal to the Governor in Council whose decision thereon shall be final and conclusive.

- 6. No person shall, save under my written permit containing such terms and conditions as may be specified therein-
 - (a) prepare, make or bake bread for sale whether by retail or wholesale, except at the bakery of a registered baker;
 - (b) prepare, make or bake bread for sale other than from wheat flour;
 - (c) sell or expose for sale, any bread, except bread prepared, made or baked from wheat flour;
 - (d) sell or expose for sale what is commonly known as franzola;
 - (e) sell or expose for sale, any wheat or flour;
 - (f) purchase any wheat or flour except from the Government.
- 7. No registered baker shall, save under my written permit containing such terms and conditions as may be specified therein, keep, or allow or suffer to be kept, in his bakery any flour other than wheat flour.
- 8. Every registered baker shall keep in his bakery a book in which he shall enter or cause to be entered at the time hereinafter specified the following particulars:—
 - (a) the actual amount of wheat or wheat flour received with reference to the relative invoice numbers as soon as such wheat or wheat flour is received;
 - (b) the actual amount of flour and bran or other extraneous matter produced from any wheat received by him as in paragraph (a) hereof and the mill or mills at which the milling of such wheat was done;
 - (c) at the end of each day the daily quantity of flour used for the preparation of bread;
 - (d) at the end of each day the number of loaves of bread prepared, made or baked in his bakery; and
 - (e) at the end of each month the stock in hand of wheat and wheat
- flour.

 9.—(1) No person shall sell or purchase any bread in any town or village in the Colony at a price in excess of the price specified in AEAL. S.L.

 - (ii) one oke (400 drams).
- (2) The price ex-oven at which any bread shall be sold or purchased in the Colony shall not exceed—
 - (a) In any town—
 - (i) six piastres for each loaf of one oke,
 - (ii) three piastres for each loaf of one-half oke;

- (b) In any village—
 - (i) six and a half piastres for each loaf of one oke,
 - (ii) three piastres and ten paras for each loaf of one-half oke.
- (3) The provisions of this clause shall not apply to what are commonly known as *koullouria* and *paximadia*.
- 10. Every registered baker shall permit such person as I may authorize in writing in that behalf, to enter upon his bakery and make—
 - (a) such enquiries or inspection therein; and
- (b) such inspection of any book kept under clause 8 of this Order, as may be necessary for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.
 - 11.—(a) Any bread prepared, made or baked in contravention of any of the provisions of this Order or of any term or condition of any permit issued under this Order; and
 - (b) any bread, franzola, wheat or flour sold, offered for sale or exposed for sale in contravention of any of the provisions of this Order or of any term or condition of any permit issued under this Order; and
 - (c) any wheat or flour purchased in contravention of any of the provisions of this Order or of any term or condition of any permit issued under this Order,

may be seized by such person as I may authorize in writing in that behalf, and may be disposed of in such manner as I may direct, without prejudice to any proceedings which may be taken for any such contravention.

- 12. Any person who—
- (a) acts in contravention of, or fails to comply with, any of the provisions of this Order; or
- (b) makes in any book kept under clause 8 of this Order any entry which is false in any material particular; or
- (c) fails to comply with any term or condition contained in any permit issued under this Order; or
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order,

is liable to the penalties prescribed in the Defence Regulations as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.

Provided that any permit issued under the Orders hereby repealed and subsisting on the date of the publication of this Order in the Gazette shall be deemed to be a permit issued under and for the purposes of this Order.
