In exercise of the powers vested in me by paragraph (2) of Defence Regulation 55 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, I, the Acting Governor, do hereby depute the Controller of Supplies to exercise and perform in my behalf all the powers which I am empowered to exercise and perform under the provisions of paragraph (1) of the aforesaid Defence Regulation 55.
