No. 94. THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW, 1948.**NOTICE UNDER SECTION 12 (2).**

Notice is hereby given that the immovable property, as hereinafter, is required by the Water Commission of Komi Kebir, in connection with a scheme for the supply and maintenance of a supply of water for the domestic purposes of the inhabitants of the said village under the provisions of the Water (Domestic Purposes) Village Supplies Law, 1948.
