

**No. 104. THE PUBLIC RIVERS PROTECTION LAW, 1930.****NOTIFICATION.**

1. Whereas the portion of the public river known as "Potamos tou Haji Halil", in the town of Kyrenia, beginning at the point at which it is crossed by the municipal boundary of Kyrenia, at the most northern point of plot No. 14 of the Government Survey Plan No. XII/29 and proceeding downstream to the mouth of the said river on the seashore (near the Sea View Hotel), has been declared by the Haji Halil River (Protection) Order, 1947, to be a river for the purpose of the Public Rivers Protection Law, 1930;

Notice is hereby given that from the date hereof—

- (a) the removal or carrying away of stones, shingle, gravel, sand, soil or other substance from the bed, bank or wall of the portion of the river aforesaid;
- (b) the dumping of any rubble, rubbish, sweepings or other refuse in the bed or upon any bank or wall of the portion of the river aforesaid,

is prohibited.

2. The attention of the public is drawn to the provisions of the Public Rivers Protection Law, 1930, under which any person acting in contravention of a notification issued thereunder, is liable to imprisonment not exceeding one month or to a fine not exceeding five pounds.
