GROUPING OF VILLAGES.

THE POLICE LAW, 1947.

REGULATIONS MADE BY THE COMMISSIONER OF POLICE WITH THE APPROVAL of the Governor under Section 58.

In exercise of the powers vested in me by section 58 of the Police Law, 1947, I, the Commissioner of Police, with the approval of the Governor, make the following regulations:-

I. These regulations may be cited as the Police (Amendment) Regulations, Gazettes: 1950, and shall be read as one with the Police Regulations, 1947 to 1949 Suppl. No.3: (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Police 29, 9,1949 Regulations, 1947 to 1950.

- 2. Regulation 52 of the principal Regulations is hereby amended by the deletion therefrom of paragraphs (1), (1A) and (2) and the substitution therefor of the following paragraphs:—
 - "(1) Leave to officers of and above the rank of Assistant Superintendent shall be governed by Cyprus General Orders. and Leave and Passage Regulations as in force from time to time.
 - (1A) Officers below the rank of Assistant Superintendent and non-commissioned officers and constables may be granted vacation leave at the rate of $3\frac{1}{2}$ days for each completed month of service. Leave may not be accumulated in respect of more than 36 months' service.
 - (2) Officers below the rank of Assistant Superintendent and non-commissioned officers and constables may be granted sick leave, half pay leave and leave without pay in accordance with the Cyprus General Orders relating to such leave in respect of officials paid from Personal Empluments: "extablished officers".
