No. 177. THE FOREST LAWS, 1939 AND 1948.

LICENCE UNDER SECTION 6.

In exercise of the powers vested in me under section 6 of the Forest Laws, 1939 and 1948, I, R. R. Waterer, Conservator of Forests, do hereby give licence to the inhabitants for the time being of the village of Yerani in the District of Famagusta to—

- (a) gather dead and dry fuel other than burned fuel; and
- (b) cut any part of the schinia bush growing above ground, in the Kantara Main State Forest.

Rules.

These rules may be cited as the Irrigation Division of Xerovounos-Loutros (Amendment) Rules, 1950, and shall be read as one with the Irrigation Division of Xerovounos-Loutros Rules, 1939 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of Xerovounos-Loutros Rules, 1939 and 1950.

IRRIGATION DIVISION OF KAPILIO.

Rules.

1. These rules may be cited as the Irrigation Division of Kapilio (Amendment) Rules, 1950, and shall be read as one with the Irrigation Division of Kapilio Rules, 1931 to 1942 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of Kapilio Rules, 1931 to 1950.

No. 180. THE IRRIGATION (PRIVATE WATER) ASSOCIATION LAW, 1949.

In pursuance of the provisions of sub-section (3) of section 12 of the Irrigation (Private Water) Association Law, 1949, the following Rules made by the Committee of the Irrigation Association of Kalokhorio (Lefka) ("Koshinas" Water), in the District of Nicosia, are published in the *Gazette*.

IRRIGATION ASSOCIATION OF KALOKHORIO (LEFKA) ("KOSHINAS" WATER).

Rules.

1. These Rules may be cited as the Irrigation Association of Kalokhorio (Lefka) ("Koshinas" Water) Rules, 1950.

2. In these Rules, unless the context otherwise requires—

"Commissioner" means the Commissioner of the District of Nicosia;

"Committee" means the Committee of the Irrigation Association;

"Irrigation Association" means the Irrigation Association of Kalokhorio (Lefka) ("Koshinas" Water);

"Law" means the Irrigation (Private Water) Association Law, 1949;

"List" means the list of the names and residences of the proprietors and of the extent of the interest of each proprietor in the water, as finally settled in accordance with the provisions of section 11 of the Law;

"works" means the irrigation works of the Irrigation Association.

"water" means the water commonly known as "Koshinas" Water.

3. The present Committee shall hold office for a period of three years beginning on the 23rd April, 1950. The election of each subsequent Committee shall take place in the manner hereinafter provided every third year in the first week of the month of April and it shall hold office for a period of three years from the date of the expiration of the period of office of the previous Committee.
