AND
THE LAND ACQUISITION LAWS, 1899 TO 1947.**

NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

Whereas I am of the opinion that it is expedient that certain immovable properties in the Main State Forest of Adelphi, in the District of Nicosia, in the locality of Monadhes should be acquired by the Government:

Now, therefore, in exercise of the powers vested in me by section 10 of the Forest Laws, 1939 and 1948, and sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1947, I, the Governor, do hereby declare the acquisition of the said immovable properties to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby entrust to the Conservator of Forests the supervision and effectuation of the said undertaking.

THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1948.**

APPOINTMENT UNDER SECTION 204.

Whereas the Mayor of the Municipal Corporation of Famagusta will shortly be absent from Cyprus for a period of time, and the Deputy Mayor is already out of the Colony:

Now, therefore, in exercise of the powers vested in me under section 204 of the Municipal Corporations Laws, 1930 to 1948, I, the Governor, do hereby appoint Mr. Gavriel Makris, Councillor of the same Municipal Corporation, to perform the duties and exercise the powers conferred upon the Mayor by the Municipal Corporations Laws, 1930 to 1948, during the absence from the Colony of the said Mayor and Deputy Mayor, and to have all the powers of the Mayor and be liable to the like penalties for any failure therein.

THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES
