This Order may be cited as the Main State Forest (Halevga and Koronia Group) (Amendment) Order, 1949, and shall be read as one with the Main State Forest (Halevga and Koronia Group) Order, 1941, as amended by the Main State Forests Amendment (No. 1) Order, 1942 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Main State Forest (Halevga and Koronia Group) Orders, 1941 to 1949.

2. Paragraph 1 of Part II of the Schedule to the principal Order is hereby amended by the insertion therein, in the appropriate columns of the said Schedule, of the area of land described in the Schedule hereto.
