# THE MISSIONARY EDUCATIONAL AND MEDICAL (ALIEN REGULATION) LAWS, 1922 AND 1933.

# PERMIT UNDER SECTION 8.

Whereas in pursuance of the provisions of the Missionary Educational and Medical (Alien Regulation) Laws, 1922 and 1933, the person whose name appears in the Schedule hereto has applied for a permit under the provisions of the said Laws;

And whereas the said person has given an undertaking in writing to pay all due obedience and respect to the Government of Cyprus, and while carefully abstaining from participation in political affairs, that he desires and purposes *ex animo* to work in friendly co-operation with the said Government in all matters in which his influence might properly be exerted; and, in particular, he has undertaken that if engaged in educational work, his influence will be exerted to promote loyalty to the Government of Cyprus in the minds of his pupils, and to make them good citizens of the British Empire :

Now, therefore, I, the Governor in Council, in exercise of the powers conferred by section 8 of the Missionary Educational and Medical (Alien Regulation) Laws, 1922 and 1933, do hereby grant to the person whose name appears in the first column of the Schedule hereto a permit to commence and carry on the work set down in the second column of the said Schedule.

No. 205. THE GOVERNMENT LANDS LAW, 1941.

GRANT MADE BY THE GOVERNOB UNDER SECTION 2. A. B. WRIGHT,

Governor.

I, Andrew Barkworth Wright, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, upon whom has been conferred the Decoration of the Military Cross and Bar, Governor and Commanderin-Chief in and over the Colony of Cyprus, by virtue of the powers vested in me by section 2 of the Government Lands Law, 1941, do hereby grant unto the Summer Resort Development Board of Boghaz (hereinafter referred to as "the Board") the land described in the Schedule hereto, (hereinafter referred to as "the land") subject to the conditions as follows, that is to say:—

(a) that the land shall not be registered in the name of the Board;

(b) that the Board shall use and maintain the land at all times to provide or improve public amenities in the summer resort and, for that purpose, to effect in or upon the land such improvements as the Board may deem fit :

Provided that the Board may, subject to such conditions as to it may seem fit, entrust the use and management of the land to any person during any period or periods not exceeding ten years at any one time, revocable, however, at any time upon the revocation of the grant as hereinafter provided;

(c) that if the Board shall fail to use and maintain the land as hereinbefore provided and in every such case the grant may be revoked upon giving notice therefor to the Board and thereupon the Board shall forthwith vacate the land and any improvements whatsoever effected in or upon the land shall vest in and become the property of the Crown without payment to the Board or any other person of any compensation whatsoever.

For the purposes of paragraph (c) hereof, any failure by any person entrusted with the use and management of the land to provide or improve public amenities in the summer resort shall be deemed to be failure of the Board to use and maintain the land as hereinbefore provided, rendering the grant revocable.

I, Andrew Barkworth Wright, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, upon whom has been conferred the decoration of the Military Cross and Bar, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby grant to Ahmed Mehmed, of Yialia, his heirs and successors the land described in the Schedule hereto on condition that the grantee shall not be registered therefor or mortgage, sell or in any other way dispose of the same except with the consent of the Governor previously obtained.
