

- (b) that the Board shall use and maintain the land at all times to provide or improve public amenities in the summer resort and, for that purpose, to effect in or upon the land such improvements as the Board may deem fit :

Provided that the Board may, subject to such conditions as to it may seem fit, entrust the use and management of the land to any person during any period or periods not exceeding ten years at any one time, revocable, however, at any time upon the revocation of the grant as hereinafter provided ;

- (c) that if the Board shall fail to use and maintain the land as hereinbefore provided and in every such case the grant may be revoked upon giving notice therefor to the Board and thereupon the Board shall forthwith vacate the land and any improvements whatsoever effected in or upon the land shall vest in and become the property of the Crown without payment to the Board or any other person of any compensation whatsoever.

For the purposes of paragraph (c) hereof, any failure by any person entrusted with the use and management of the land to provide or improve public amenities in the summer resort shall be deemed to be failure of the Board to use and maintain the land as hereinbefore provided, rendering the grant revocable.

GRANT MADE BY THE GOVERNOR UNDER SECTION 2.

I, Andrew Barkworth Wright, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, upon whom has been conferred the decoration of the Military Cross and Bar, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby grant to Ahmed Mehmed, of Yialia, his heirs and successors the land described in the Schedule hereto on condition that the grantee shall not be registered therefor or mortgage, sell or in any other way dispose of the same except with the consent of the Governor previously obtained,

**No. 207.****THE LAND ACQUISITION LAWS, 1899 TO 1947.****NOTIFICATION UNDER SECTION 6.**

Whereas by a notification published under No. 341 in Supplement No. 3 to the *Gazette* of 16th September, 1948, the Governor declared the acquisition of the military road known as "Nicosia bye-pass" and two strips of land, each ten feet wide, on either side of it, running through the villages of Eylenja, Palouriotissa, Beuyuk Kaimakli, Omorphita, Orta Keuy and Ayios Dhometios and Ibrahim Pasha Quarter, Nicosia Town, for use as a permanent public road, to be an undertaking of public utility;

And whereas the Commissioner of Nicosia by notice published under No. 119 in Supplement No. 3 to the *Gazette* of 30th March, 1950, gave particulars of the lands as aforesaid required in connection with the notification as aforesaid:

And whereas in compliance with the aforesaid Laws the Commissioner forwarded to the Governor the required recommendations, plans and particulars, no objections having been made;

And whereas the Governor has approved the plans and particulars submitted and considers it expedient having regard to all the circumstances of the case that the lands in question be acquired:

Now, therefore, in exercise of the powers vested in me by section 6 of the Land Acquisition Laws, 1899 to 1947, I, the Governor, do hereby sanction the acquisition, under the provisions of the aforesaid Laws, of the immovable properties situated in the villages of Eylenja, Palouriotissa, Beuyuk Kaimakli, Omorphita, Orta Keuy and Ayios Dhometios and Ibrahim Pasha Quarter, Nicosia Town, particulars whereof are specifically set out in the notice of the Commissioner of Nicosia published under No. 119 in Supplement No. 3 to the *Gazette* of 30th March, 1950.
