CIVIL AVIATION ACT, 1949.

AIR NAVIGATION ORDER, 1949.

The Minister of Civil Aviation pursuant to Article 64 of the Air Navigation Order, 1949 (hereinafter referred to as "the Order") hereby authorizes the Chairman of the Air Transport Licensing Authority in the Colony of Cyprus, to exercise in the said Colony the powers of the Minister under the Order which are hereinafter specified, that is to say:—

- (a) As to licence granted under Article 20 of the Order entitling persons to act as members of the operating crew of an aircraft registered in the United Kingdom—
  - (i) to renew a licence in accordance with paragraph (3) of that Article;

- (ii) to take action with respect to a licence in accordance with paragraph (4) (a) (ii) and (iv), paragraph (5) and paragraph (6) of that Article;
- (b) As to licences granted under paragraph (3) of Article 31 of the Order to persons to act in the capacity of arcraft radio maintenance engineers-

(i) to renew a licence in accordance with sub-paragraph (c) (i)

of that paragraph;

(ii) to extend in accordance with sub-paragraph (d) of that paragraph the rating included in a licence;

(c) To issue and renew a validation pursuant to Article 21 of the Order;

(d) As to licences issued under the Air Navigation (Consolidation) Order, 1923-

To renew pursuant to paragraph (2) (b) of Article 73 of the Order and Section XX of the Air Navigation (General) Regulations, 1949,

(i) a pilot's licence to fly public transport or aerial work aircraft so that such licence may remain in force until a date not later than the thirtieth day of September, 1950; and

(ii) an aircraft navigator's licence 1st or 2nd class, so that such licence may remain in force until a date not later than the thir fieth day of June, 1950,

upon his being satisfied, having regard to any appropriate requirements contained in the Order or in the said Regulations, that any such powers as aforesaid should in a particular case be exercised.

## IRRIGATION DIVISION OF KALIANA.

## Rules.

1. These rules may be cited as the Irrigation Division of Kaliana (Amendment) Rules, 1950, and shall be read as one with the Irrigation Division of Kaliana Rules, 1937 (hereinafter referred to Gazette: as "the principal Rules"), and the principal Rules and these rules Suppl. No. 3 may together be cited as the Irrigation Division of Kaliana Rules, 29.1.1937 1937 and 1950.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the word "six" and the substitution therefor of the word "sixty". (M.P. 1062/50.)
