No. 254. THE PRISON DISCIPLINE LAW, 1879.

NOTICE UNDER SECTION 2.

THE SECURITIES (CONTROL OF TRANSFER) LAW, 1948.

DECLARATION BY THE ACCOUNTANT-GENERAL UNDER SECTION 2.

In exercise of the powers vested in me by section 2 of the Securities (Control of Transfer) Law, 1948, in relation to the definition of the expression "sterling area", I hereby declare the territories set out in the Schedule hereto to be included in the definition "sterling area" for the purposes of the said Law, in addition to the United Kingdom and the Isle of Man mentioned in the said definition.
