## THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1950.

## ORDER IN COUNCIL No. 2425

MADE UNDER SECTION 116 (a) (i).

*Authority to the Council of the Municipal Corporation of Lefkoniko to contract a loan.*A. B. WRIGHT,  
Governor.

Whereas by an Order in Council No. 2415 dated the 6th day of June, 1950 (hereinafter referred to as "the principal Order"), published under Notification No. 200 in Supplement No. 3 to the *Gazette* of the 9th June, 1950, authority was given to the Municipal Corporation of Lefkoniko to contract a loan from the Lefkoniko Co-operative Credit Society on the terms and conditions therein laid down;

And whereas it was found desirable to amend clause 1 of the principal Order:

Now, therefore, in exercise of the powers vested in me by section 116 (a) (i) of the Municipal Corporations Laws, 1930 to 1950, and of every other power thereunto enabling, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. Clause 1 of the principal Order shall be amended by the insertion therein immediately after paragraph (a) of the following paragraph:—

"(aa) If the rate of interest chargeable by the Lender on loans issued to its members is increased, the rate of interest on the sum borrowed in virtue of this Order may be likewise increased by the Lender but so that it will in no case exceed five per centum (5%) per annum, and thereafter the annual instalments subsequently becoming due and payable as hereinbefore provided shall be adjusted accordingly;"

2. This Order shall be read as one with the principal Order and it shall be deemed to have been made with effect from the 6th day of June, 1950.

## THE INCREASE OF RENT (RESTRICTION) LAWS, 1942 TO 1949.

## NOTIFICATION UNDER SECTION 4.

In exercise of the powers vested in me by section 4 of the Increase of Rent (Restriction) Laws, 1942 to 1949, and of every other power thereunto enabling, I, the Governor, do hereby order that the Notification No. 257 published in Supplement No. 3 to the *Gazette* of the 4th September, 1947, as amended by the Notification No. 485 published in Supplement No. 3 to the *Gazette* of the 22nd December, 1949, be further amended by the deletion from the second column of the Schedule thereto of the name of Mr. Vedad R. Dervish (under heading "Rent Assessment Board") in respect of the Rent Restriction Area of Paphos, and the substitution therefor of the name of Mr. Michael A. Michaelides who is appointed to be the President of the Rent Assessment Board for the said Rent Restriction Area.
