THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) (CYPRUS) ORDER, 1946.

ORDER MADE BY A COMPETENT AUTHORITY UNDER DEFENCE **REGULATION 61.**

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purpose of Defence Regulation 61 as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946, I hereby order as follows :-

1. This Order may be cited as the Supplies and Services (Zivania Gazettes: Control) (Amendment) Order, 1950, and shall be read together with the Supplement Control) (Amendment) Urder, 1990, and shan be road to gooder and this Order No. 3: Supplies and Services (Zivania Control) Orders, 1949 (hereinafter referred No. 3: 8.9.1949 to as "the principal Order") and the principal Order and this Order 22,9,1949 may together be cited as the Supplies and Services (Zivania Control) Orders, 1949 and 1950.

2. Clause 2 of the principal Order is hereby amended by the insertion in the definition of "producer" immediately after the word "Gazette"

for 'the manufacture of intoxicating liquor under the Intoxicating Liquor (Manufacture) Licensing Laws, 1941 to 1948, irrespective of whether he would otherwise be a producer ;"

3. Clause 10 of the principal order is hereby deleted and the following clause substituted therefor :--

"10. Every person shall permit such person as the Vine Products Controller or the Commissioner of the District may authorize in writing in that behalf to enter upon and inspect his premises and take such steps, including the sealing of any apparatus used or which may be used for producing zivania as will be found necessary to ensure that the provisions of this Order have been or are being complied with."

4. Clause 11 (d) of the principal Order is hereby amended by the insertion in the second line immediately after the word "duties" of the following :-

" or removes, breaks or in any way interferes with, any seals affixed on 'any zivania producing apparatus."

THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1948.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF LIMASSOL.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1948, and otherwise, the Council of the Municipal Corporation of Limassol hereby make the following bye-laws :-

1. These bye-laws may be cited as the Municipal Corporation (Limassol) (Amendment No. 2) Bye-laws, 1949, and shall be read as one -with the Municipal Corporation (Limassol) Bye-laws, 1931 to 1949 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Limassol) Bye-laws, 1931 to (No. 2) 1949.

2. Bye-laws 34, 47 and 75 of the principal Bye-laws are hereby amended by the deletion of the words "except on Sundays when it shall be closed at 2 p.m.", wherever they appear in the said bye-laws, and the substitution therefor of the words "except on Sundays when it shall be closed during the whole day and on such other day of the week to be fixed by the Council when it shall be closed at 2 p.m.".
