# No. 341. THE DANGEROUS DRUGS LAWS, 1925 TO 1932. ORDER IN COUNCIL No. 2431

ORDER IN COUNCIL No. 2431 MADE UNDER SECTION 11 (2).

#### A. B. WRIGHT, Governor.

Whereas it appears to the Governor that the drugs specified in the Schedule to this Order are productive, if improperly used, or are capable of being converted into a substance which is or is likely to be productive, if improperly used, of ill effects substantially of the same character or nature as or analogous to those produced by morphine or cocaine;

And whereas by Order in Council No. 2481 dated the 5th March, 1948, made under the Dangerous Drugs Laws, 1925 to 1932, it was declared that Part III of the said Laws should apply to, amongst other drugs, a certain form of the drug known as amidone, and its salts, and preparations, admixtures, extracts or other substances containing any proportion of that form of amidone;

And whereas all forms of the drug known as amidone, and its salts, and preparations, admixtures, extracts and other substances containing any proportion of any form of amidone are amongst the drugs specified in the Schedule to this Order, and it is expedient accordingly that the said Order in Council No. 2281 of the 5th March, 1948, should be amended so as to omit reference to the said form of amidone, and its salts, and preparations, admixtures, extracts or other substances containing any proportion of the said form of amidone :

Now, therefore, in exercise of the powers vested in me by section 7 of the Dangerous Drugs (Amendment) Law, 1932, and section 11 (2) of the Dangerous Drugs Laws, 1925 to 1932, I, the Governor, with the advice of the Executive Council, do hereby order and declare as follows :--

- (1) Part III of the Dangerous Drugs Laws, 1925 to 1932, shall apply to the drugs specified in the Schedule to this Order in the same manner as the said Part III applies to the drugs mentioned in section 11 (1) of the Dangerous Drugs Laws, 1925 to 1932.
- (2) In the Schedule to the Dangerous Drugs Laws, 1925 to 1932, Order in Council No. 2281 of 1948, the following words, that is to say, "Amidone (dl-2-dimethylamino-4: 4-diphenylheptane-5-one), its salts and any preparation, admixture, extract or other substance containing any proportion of amidone" shall be omitted.

2/ This Order shall be deemed to have come into force on the 1st day of May, 1950.

#### SCHEDULE.

- 1. Alphaprodine (a-4-propionoxy-4-phenyl-1: 3-dimethyl-4-piperidine), its salts and any preparation, admixture, extract or other substance containing any proportion of alphaprodine.
- 2. Amidone (6-dimethylamino-4: 4-diplenylheptane-3-one), its salts and any preparation, admixture, extract or other substance containing any proportion of amidone.
- 3. Betaprodine (b-4-propionoxy-4-phenyl-1: 3-dimethyl-4-piperidine), its salts and any preparation, admixture, extract or other substance containing any proportion of betaprodine.
- 4. Hydroxypethidine (ethyl 4-m-hydroxyphenyl-1-methylpiperidine-4carboxylate), its salts and my preparation, admixture, extract or other substance containing any proportion of hydroxypethidine.
- 5. Isoamidone (6-dimethylamino-4: 4-diphenyl-5-methylhexan-3-one), its salts and any proparation, admixture, extract or other substance containing any proportion of isoamidone.
- 6. Ketobemidone (4-propionyl-4-m-hydroxyphenyl-1-methylpiperidine), its salts and any preparation, admixture, extract or other substance
  - containing any proportion of ketobemidone.
- 7. Methadol (6-d/methylamino-4: 4-diphenylheptane-3-ol), its salts and any preparation, admixture, extract or other substance containing any proportion of methadol.
- 8. Methadyl acetate (6-dimethylamino-4: 4-diphenyl-3-heptyl acetate), its salts and any preparation, admixture, extract or other substance containing any proportion of methadul acetate.
- 9. Phenadoxone (6-morpholino-4: 4-diphenylheptane-3-one), its salts and any preparation, admixture, extract or other substance containing any proportion of phenadoxone.

No. 342. THE CUSTOMS LAWS, 1936 TO (No. 3) 1948.

ORDER IN COUNCIL No. 2432 MADE UNDER SECTION 65.

In exercise of the powers vested in me by section 65 of the Customs Laws, 1936 to (No. 3) 1948, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. This Order may be cited as the Wharfage Dues (Export of Concentrated Carob Extract (" Carob Honey ")) Order, 1950.

2. There shall be levied and collected upon the export from the Colony of concentrated carob extract ("carob honey") wharfage dues at the special rate of one-half plastre for each tin or other receptacle containing such carob extract not exceeding 50 okes in weight.
