PERMIT UNDER SECTION 8.

Whereas in pursuance of the provisions of the Missionary Educational and Medical (Alien Regulation) Laws, 1922 and 1933, the person whose name appears in the Schedule hereto has applied for a permit under the provisions of the said Laws;

And whereas the said person has given an undertaking in writing to pay all due obedience and respect to the Government of Cyprus, and while carefully abstaining from participation in political affairs, that he desires and purposes *ex animo* to work in friendly co-operation with the said Government in all matters in which his influence might properly be exerted; and, in particular, he has undertaken that if engaged in educational work, his influence will be exerted to promote loyalty to the Government of Cyprus in the minds of his pupils, and to make them good citizens of the British Empire :

Now, therefore, I, the Governor in Council, in exercise of the powers conferred by section 8 of the Missionary Educational and Medical (Alien Regulation) Laws, 1922 and 1933, do hereby grant to the person whose name appears in the first column of the Schedule hereto a permit to commence and carry on the work set down in the second column of the said Schedule on condition that the said person establishes himself in Cyprus within 6 months from the date hereof.

No. 344. THE LAND ACQUISITION LAWS, 1899 TO 1947.

NOTICE UNDER SECTIONS 2, 3 AND 4.

A. B. WRIGHT,

Governor.

Whereas it has been represented to me that it is desirable in the public interest to construct, within the limits of the village of Strovolos, a reservoir in connection with a scheme to provide or improve the supply of wholesome water for domestic purposes in the surrounding areas, in the District of Nicosia:

Now, therefore, I, Andrew Barkworth Wright, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Commander of the Most Excellent Order of the British Empire, upon whom has been conferred the Decoration of the Military Cross and Bar, Governor and Commander-in-Chief in and over the Colony of Cyprus, by virtue of the powers vested in me by sections 2 and 3 of the Land Acquisition Laws, 1899 to 1947, do hereby declare the construction, within the village area of Strovolos, of a reservoir, in connection with the aforesaid scheme, to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking under the provisions of the said Laws and do hereby, by virtue of the powers vested in me by section 4 of the said Laws, entrust the supervision of the said undertaking to the Water Engineer.

And further that the period set out in the Schedule to the aforementioned Laws (in connection with claims by persons claiming any rights or interests) shall be abridged from six weeks to ten days.

The Notification published under No. 362 in Supplement No. 3 to the Gazette of 29th September, 1949, is hereby cancelled.

THE QUARANTINE LAW, 1932.

NOTIFICATION UNDER SECTION 4.
