## No. 371. THE LAND ACQUISITION LAWS, 1899 TO 1947.

#### Notification under Section 2.

A. B. WRIGHT,

Whereas it has been represented to me that it is desirable in the public interest that the Municipal Corporation of Kyrenia which has been recognized as a public body for the purposes of the Land Acquisition Laws, 1899 to 1947, should acquire certain land situated at the locality Boghazi in the village of Bellapais on which a certain borehole from which Kyrenia Town obtains its water supply is found, together with the strip of land over which the masonry channel conducting the water runs;

Now, therefore, I, the Governor, in exercise of the powers vested in me by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1947, do hereby declare the acquisition of the said lands to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking and do hereby, by virtue of the powers vested in me by section 4 of the said Laws, entrust the supervision and effectuation of the said undertaking to the Council of the Municipal Corporation of Kyrenia.

From and after the date of the publication of this notice in the Cyprus Gazette no building shall be erected, reconstructed or repaired and no tree shall be felled within the area adjacent to an ancient monument to wit Kolossi Castle situated in the village of Kolossi, in the District of Limassol, comprising the plots specified in the Schedule hereto save in accordance with the terms of a permit in writing from the Commissioner previously obtained.
