30 ÷. In exercise of the powers vested in him by section 11 of the Antiquities Laws, 1935 and 1945, His Excellency the Governor has been pleased to order and hereby orders as follows :---- 11

From and after the date of the publication of this notice, in the Cyprus Gazette no building shall be erected, reconstructed or repaired and no tree shall be felled within the areas adjacent to an ancient monument to wit the "Topkhane" situated near the Paphos Gate in the town of Nicosia (known also as Madonna del Castello), comprising the plots specified in the Schedule hereto, save in accordance with the terms of a permit in writing from the Commissioner previously obtained.

### SCHEDULE.

All those areas of land situated in Ayios Andreas Quarter, Nicosia, comprising one donum or thereabouts, including plots Nos. 63/3 (part), 11, 12, 13/1, 13/2, 13/3, 14 and 68.4 (part) of Block No. 12 of Ayios Andreas Quarter, Nicosia, more particularly defined as the two areas edged in red on the Government Survey Plan Serial No. 1465, deposited in the office of the Director of Land Registration and Surveys, Nicosia.

With reference to the Notification published under No. 344 in Supplement No. 3 to Gazette No. 3515 of the 30th August, 1950, notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned therein :-

All that area of land situated at Strovolos, in the District of Nicosia, at the locality Perneres, comprising 6 donums, 2 evlcks and 800 sq. ft. or thereabouts bounded by private property and Crown land, and including plot No. 56 of Block "J", Strovolos, belonging to Costas Savva Hj.
