THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

ORDER IN COUNCIL No. 2436

MADE UNDER SECTION 9A.

*Authority to the Village Health Commission of Ayios Andronikos,
Famagusta District, to contract a loan.*

In exercise of the powers vested in the Governor by section 9A of the Public Health (Villages) Laws, 1936 to 1948, the Governor, with the advice of the Executive Council, does hereby order as follows:—

1. The Village Health Commission of Ayios Andronikos (hereinafter referred to as "the Commission") shall be at liberty to borrow from the Loan Commissioners (hereinafter referred to as "the Lender"), the sum of six hundred pounds (£600) at a rate of interest not exceeding four per centum (4%) per annum, subject to the following terms and conditions, that is to say:—

(a) the sum borrowed shall be repayable by the Commission to the Lender in ten equal annual instalments (comprising sinking fund and interest);

(b) the Commission shall, in each year and until final repayment of the amount borrowed, insert in the annual estimates as a charge on its revenues the annual instalment payable in the year to which such estimates relate;

(c) the sum borrowed shall be utilized by the Commission for the purpose of improving the streets within the village.

2. For the purposes of securing the repayment of the sum due under the loan the Commission is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all fees, charges and rates now payable or hereafter to become payable to the Commission under the provisions of the Public Health (Villages) Laws, 1936 to 1948.

THE SHIPS AND AIRCRAFT (TRANSFER RESTRICTION) ACT, 1939.

GENERAL SANCTION FOR THE TRANSFER OF CERTAIN SHIPS.

The Governor, in exercise of the powers duly delegated to him under the provisions of the Ships and Aircraft (Transfer Restriction) Act, 1939 (hereinafter referred to as "the Act"), hereby gives his sanction for the purpose of section 1 (1) of the Act to the transfer, to persons qualified to own British ships in accordance with the provisions of section 1 of the Merchant Shipping Act, 1894, of any ship registered at any port of Registry in Cyprus or any share in any such ship, and to the mortgage to such persons of any such ship or share therein, and to the transfer to such persons of any mortgage of any such ship or share.

The General Sanction for the transfer of certain ships published in Supplement No. 3 to the *Gazette* of the 24th July, 1947, under No. 215 is hereby revoked.
