RULES MADE BY THE VILLAGE HEALTH COMMISSION OF AYIA TRIAS UNDER SECTION 9.

In exercise of the powers vested in them under section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Ayia Trias hereby make the following rules :—

1. These rules may be cited as the Village Health (Ayia Trias) (Amendment) Rules, 1950, and shall be read as one with the Village Health (Ayia Trias) Rules, 1941 (hereinafter referred to as “the principal Rules”), and the principal Rules and these rules may together be cited as the Village Health (Ayia Trias) Rules, 1941 and 1950.

2. Rules 20 and 46 of the principal Rules are hereby repealed and the following rules substituted therefor, respectively :—
