**THE FOREST (PROTECTION AGAINST INCENDIARISM)  
LAW, 1946.**

**ORDER IN COUNCIL No. 2441**  
**MADE UNDER SECTION 10.**

In exercise of the powers vested in me by section 10 of the Forest (Protection Against Incendiarism) Law, 1946, which continues and has effect for a further period of twelve months beginning on the 25th July, 1950, by an Order in Council published under No. 266 in Supplement No. 3 to the *Gazette* of the 20th July, 1950, I, the Governor, with the advice of the Executive Council, do hereby order that the Schedule to the said Law shall be amended by the addition thereto under the heading "Paphos District" of the following villages in their proper alphabetical order, that is to say:—

Arkhimandrita, Pano  
Kouklia  
Marona  
Phasoula  
Souskiou."

**THE AGRICULTURAL PRODUCE (EXPORT) LAW, 1933.**

**REGULATIONS MADE UNDER SECTION 8.**

In exercise of the powers vested in me by section 8 of the Agricultural Produce (Export) Law, 1933, I, the Governor, with the advice of the Executive Council, do hereby make the following regulations:—

1. These regulations may be cited as the Agricultural Produce (Dried Figs) Export (Amendment) Regulations, 1950, and shall be read as one with the Agricultural Produce (Dried Figs) Export Regulations, 1946,

(hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Agricultural Produce (Dried Figs) Export Regulations, 1946 and 1950.

2. Regulation 9 of the principal Regulations is hereby repealed and the following regulation substituted therefor :—

"9. All dried figs for export shall be properly packed either in clean, new wooden boxes made of dry, properly seasoned wood planed on both sides, or in clean, new cardboard cartons ; such boxes or cartons shall be lined with grease proof or other similar paper and shall be of such size and dimensions as may be specified by the Director of Agriculture, so however as to hold not more than 20 cokes of figs :

Provided that dried figs of the same variety may be packed in small packets of cellophane or other similar material if such packets are placed in boxes or cartons of the kind and dimensions described above and the number of such packets and their total net weight is clearly marked on the outside of such boxes or cartons."

**No. 462. THE FOREST LAWS, 1939 AND 1948 (Section 10)**  
AND  
**THE LAND ACQUISITION LAWS, 1899 TO 1947.**

**NOTIFICATION OF SANCTION OF ACQUISITION UNDER SECTION 6.**

Whereas by a notification published under No. 192 in Supplement No. 3 to the *Gazette* of the 1st June, 1950, the Governor declared the acquisition of certain immovable properties in the Main State Forest of Adelphi, in the District of Nicosia, at the locality "Monadhes", to be an undertaking of public utility ;

And whereas the Commissioner of Nicosia and Kyrenia, by notice published under No. 336 in Supplement No. 3 to the *Gazette* of 24th August, 1950, (hereinafter referred to as "the notice") gave particulars of the immovable properties as aforesaid required in connection with the notification as aforesaid ;

And whereas in compliance with the aforesaid Laws the Commissioner forwarded to the Governor the required recommendations, plans and particulars, no objection having been made ;

And whereas the Governor has approved the plans and particulars submitted and considers it expedient, having regard to all the circumstances of the case, that the immovable properties in question be acquired :

Now, therefore, in exercise of the powers vested in me by section 6 of the Land Acquisition Laws, 1899 to 1947, I, the Governor, do hereby sanction the acquisition, under the provisions of the aforesaid Laws, of the immovable properties situated in the Main State Forest of Adelphi, in the District of Nicosia, at the locality "Monadhes", particulars whereof are specifically set out in the notice.
