

3. The foreshore commences at the north boundary of field 151 (belonging to Hambis Haji Philippou), sheet 24, plan 26.E at the locality known as "Louman", and thence follows the line along the coast in a general south and south-easterly direction to a point situated to the southern side of field 67, sheet 24, plan 35.W near the Salamis Forest, and extends to a depth of 50 yards from high water mark throughout its length.

4. The foreshore commences at a point situated at the junction of the foreshore with the south face of the main jetty in Famagusta Harbour and thence follows the line along the coast in a general southerly and south-easterly direction to a point situated to the eastern boundary of plot 47 (belonging to Paraskevas D. Lordos), sheet 33, plan 13.4 IV and extends to a depth of 50 yards from high water mark throughout its length.

NOTE.—Maps showing above areas are kept in the offices of the Commissioner, Famagusta, Divisional Engineer, Famagusta, Superintendent of Police, Famagusta, Land Registry Office, Famagusta, and with Mukhtars of Trikomo, Boghaz and Ayios Seryios, and all concerned should see them and make sure of the exact areas.

### THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

The following rules made by the Village Health Commission of Kolossi, in the District of Limassol, and approved by the Commissioner, are published in the *Gazette*.

#### RULES MADE BY THE VILLAGE HEALTH COMMISSION OF KOLOSSI UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Kolossi hereby make the following rules:—

1. These rules may be cited as the Village Health (Kolossi) (Amendment) Rules, 1950, and shall be read as one with the Village Health (Kolossi) Rules, 1938 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Village Health (Kolossi) Rules, 1938 and 1950.

2. The following rules shall be substituted for rules 20 and 46, respectively, of the principal Rules:—

"Rule 20. The following fees shall be paid by the owner of or the person slaughtering any animal in the slaughter-house, that is to say:—

(a) For every goat, kid, lamb or sheep .. .. .	-	3
(b) For every swine .. .. .	-	6
(c) For every bullock, camel, cow or ox .. .. .	-	6

Rule 46.—(1) The following fees shall be paid by every person exposing for sale any fresh meat in the meat market, that is to say:—

(a) For every carcass of sheep, goat, kid or lamb or part thereof .. .. .	-	6
(b) For every carcass of swine, camel, bullock, cow or ox or part thereof .. .. .	1	3

(2) The fees in paragraph (1) of this rule prescribed shall not be payable by any person exposing for sale any fresh meat in the meat market, who is a monthly or yearly lessee of any shop, stall or place in the meat market under rule 45 of these rules."

3. The following Chapter shall be added to the principal Rules:—

#### "Chapter 1.—Market of Perishable Goods.

26. The Village Health Commission may from time to time by public notification appoint any premises or place within the area of the village to be the market of perishable goods.

27. No person shall sell or expose for sale any perishable goods at any place within the area of the village, except at the market of perishable goods appointed by the Village Health Commission.

28. The management and control of the market of perishable goods are hereby vested in the person appointed from time to time by the Village Health Commission to be the Inspector of such market (hereinafter in this Chapter of these rules referred to as 'the Inspector') subject to the instructions which he may from time to time receive from the Village Health Commission.

29. The market of perishable goods shall be opened and shall be kept open daily from sunrise to sunset except on Sundays when it shall be closed at 2 p.m. :

Provided that the said market may be opened or kept open with the permission of the Inspector at such other time and for such other period as may be required.

30. The place or places at which and the manner in which perishable goods shall be exposed for sale within the market of perishable goods shall be appointed and regulated by the Inspector in accordance with the instructions he may from time to time receive from the Village Health Commission.

31. All perishable goods kept or exposed for sale within the market of perishable goods shall be open at all times to inspection by the Village Health Commission, the Medical Officer and the Inspector.

32. The following fees shall be paid by every person exposing for sale any perishable goods in the market of perishable goods, that is to say :—

33. No person shall bring or cause to be brought into the market of perishable goods :—

- (a) any skin, whether fresh or dry, of any animal, or
- (b) any pork, whether fresh or dry, or
- (c) any preparation made of the flesh of any swine.

34. Every person selling any perishable goods within the market of perishable goods shall, to the satisfaction of the Village Health Commission, the Medical Officer and the Inspector, at all times keep his shop, stall or other place occupied by him and all furniture or receptacles in or connected with his shop, stall or place in a clean and sanitary condition and shall sweep his shop, stall or place each night before leaving the same.

35. No person shall place or hung up within the market of perishable goods any perishable goods or things so that they project into or over any passage, pavement or footway in the market of perishable goods in such a way as to obstruct or incommode the passage of any person along the said passage, pavement or footway.

36. All perishable goods kept or exposed for sale in the market of perishable goods, which in the opinion of the Medical Officer or the Village Health Commission are unfit for human consumption, may be seized and destroyed by the Inspector.

37. Every fee payable under this Chapter of these rules shall be paid to the Inspector."

Part II of the Schedule to the principal Rules is hereby amended by the deletion therefrom of the words " Rules 1, 2, 21, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, 37, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58, 61, 62, 63, 78 and 81 ." and the substitution therefor of the words " Rules 1, 2, 21, 49, 50, 51, 52, 53, 54, 55, 56, 57, 58, 61, 62, 63, 78 and 81 ".
