THE DEFENCE (IMPORTATION OF GOODS) REGULATIONS,
1943 TO 1948.

OPEN GENERAL IMPORT LICENCE No. 10850.

In exercise of the powers vested in me by virtue of the Defence (Importation of Goods) Regulations, 1943 to 1948, I hereby grant to any importer registered under the provisions of the Defence (Control of Sale Prices of Imported Articles) Orders, 1943 to (No. 2) 1948, an Open General Import Licence under No. 10850 to import into the Colony in any quantity any of the goods enumerated in the Schedule hereto and originating in the following countries:—

Austria, Belgium, Denmark, Eire, France, Greece, Western Germany, Holland, Italy, Iceland, Luxembourg, Norway, Portugal, Sweden, Switzerland, Turkey and Trieste:

Provided that in all cases covered by this licence payment for the goods shall be made in sterling.

2. This Open General Import Licence is deemed to be a written licence issued by me under regulation 2 (1) (a) of the Defence (Importation of Goods) Regulations, 1943 to 1948, and is subject to the provisions of regulation 2 (1) (b) of the said Regulations.
