A PROCLAMATION.

A. B. WRIGHT,

Whereas there now exists in the District of Paphos a settlement known as "Nea Dhimmata";

And whereas it is expedient that the said settlement be formed as

a. village:

Now, therefore, in exercise of the powers vested in me by the provisions of the Village Authorities Laws, 1931 to (No. 2) 1937, and of every other power and authority thereunto enabling, I, the Governor, do hereby order and proclaim as follows:—

(a) that as from the 7th day of December, 1950, the said settlement be formed as a village in the District of Paphos under the name of "Nea Dhimmata" and for all administrative purposes be

considered as such;

(b) that the area described in Part I of the Schedule hereto, heretofore reckoned within the boundaries of the village of Pomos, in the District of Paphos, and that the area described in Part II of the said Schedule, heretofore reckoned within the boundaries of the village of Ayia Marina, in the District of Paphos, form part of the lands of the village "Nea Dhimmata" hereby formed, and that the said areas of the aforesaid villages of Pomos and Ayia Marina be altered accordingly.

SCHEDULE.

PART I.

Lands transferred from the village of Pomos to the village of Nea Dhimmata.

The boundary commences at the most eastern point of plot No. 169 of the Government Survey Plan No. XVII/63, locality "Lourin", which point is at the junction of the forest delimitation line of the Paphos Main State Forest, with the stream "Argakin tou Symvoulou" and proceeds south-eastwards along the left bank of the said stream to the Government triangulation point No. 1171/4 on the Government Survey Plan No. XXVI/8, locality "Stavros tou Symboulou"; thence south-westwards in a straight line to the junction of the stream "Argaki ton Phteroudhion" with the village boundary between the villages of Ayia Marina and Pomos, locality "Laoni tis Pholias tis Yerakas"; thence north-westwards along the said village boundary to the south-western

corner of plot No. 13 of the Government Survey Plan No. XVII/62, locality "Vrysi", which corner is on the main road leading from the village of Polis to the village of Pomos; thence northwards along the said main road to the north-western corner of plot No. 215 of the Government Survey Plan No. XVII/63; thence eastwards, along the boundary of and including the said plot, to the forest cairn No. 553, Paphos Forest, on the Government Survey Plan No. XVII/62; thence eastwards along the forest delimitation line to the forest cairn No. 555, which cairn is at the most western point of plot No. 207 of the Government Survey Plan No. XVII/63; thence north-eastwards, along the boundary of and including the said plot, to the forest cairn No. 559 of the said forest; thence northeastwards along the forest delimitation line to the point of commencement.

This area is the area hatched yellow on the Government Survey Plan

PART II.

Lands transferred from the village of Ayia Marina to the village of Nea Dhimmata.

The boundary commences at the north-western corner of plot No. 36 of the Government Survey Plan No. XXVI/6, locality "Panodhromos", which corner is on the main road leading from the village of Polis to the village of Pomos, and proceeds eastwards along the village boundary between the villages of Ayia Marina and Pomos, to the forest cairn No. 529 of the Paphos Main State Forest, which cairn is at the north-eastern corner of plot No. 67 of the Government Survey Plan No. XXVI/7, locality "Shinnovounos"; thence westwards along the said forest delimitation line to the most eastern point of plot No. 36 of the Government Survey Plan No. XXVI/6, locality "Panodhromos"; thence south-westwards and northwards along the boundary of and including the said plot to the point of commencement.

THE CENSUS LAW, 1946.

ORDER IN COUNCIL No. 2448
MADE UNDER SECTION 3.

A. B. WRIGHT, Governor.

In exercise of the powers vested in me by section 3 of the Census Law, 1946, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

- 1. This Order may be cited as the Census (Employment and Production) Order, 1950.
- 2. A census shall be taken in Cyprus during the remaining part of the year 1950 and during the year 1951.
