PART II.

Lands transferred from the village of Ayia Marina to the village of Nea Dhimmata.

The boundary commences at the north-western corner of plot No. 36 of the Government Survey Plan No. XXVI/6, locality "Panodhromos", which corner is on the main road leading from the village of Polis to the village of Pomos, and proceeds eastwards along the village boundary between the villages of Ayia Marina and Pomos, to the forest cairn No. 529 of the Paphos Main State Forest, which cairn is at the north-eastern corner of plot No. 67 of the Government Survey Plan No. XXVI/7, locality "Shinnovounos"; thence westwards along the said forest delimitation line to the most eastern point of plot No. 36 of the Government Survey Plan No. XXVI/6, locality "Panodhromos"; thence south-westwards and northwards along the boundary of and including the said plot to the point of commencement.

This area is the area hatched blue on the Government Survey Plan Serial No. 1485.

THE CENSUS LAW, 1946.

ORDER IN COUNCIL No. 2448

MADE UNDER SECTION 3.

A. B. WRIGHT,
Governor.

In exercise of the powers vested in me by section 3 of the Census Law, 1946, I, the Governor, with the advice of the Executive Council, do hereby order as follows:—

1. This Order may be cited as the Census (Employment and Production) Order, 1950.
2. A census shall be taken in Cyprus during the remaining part of the year 1950 and during the year 1951.

3. Returns and supplementary returns for the purpose of the census shall be made by all employers of gainfully occupied labour and also by self-employed persons, companies, partnerships, co-operative societies and all corporations in respect of the matters set out in the Schedule hereto.

SCHEDULE.

- (i) In respect of labour employed (including self-employed persons and working proprietors) :—The number of persons employed, by sex, age-group, degree of skill, kind of work, hours of work, method of payment, earnings and wage-rates.
- (ii) In respect of material production :—The nature of work done ; quantities and values of all the materials bought ; quantities and values of all the fuel, light and power and of all other goods and services bought ; kind of work given out and amount paid for it ; kind of work done for others and amount received for it ; cost of repairs and maintenance of buildings, plants, machinery and vehicles. Depreciation of equipment ; value of work in progress and way of valuation. Quantities and values of products finished but yet unsold. Quantities and receipts in respect of finished products sold. Stocks.
- (iii) In respect of services rendered :—The kind of services rendered ; operating expenses ; receipts.

THE ELEMENTARY EDUCATION LAWS, 1933 TO 1950.

ORDER MADE UNDER SECTION 71.

Whereas the Governor has, under section 52 of the Elementary Education Laws, 1933 to 1950, ordered the Town Committees and Village Commissions for Greek-Orthodox Schools mentioned in the second column of the Schedule hereto to provide school buildings, premises, playgrounds, yards, gardens or teachers' dwellings ;

And whereas the necessary estimates and plans have been prepared under section 53 of the above-mentioned Laws ;

And whereas loans amounting to the sums mentioned in the third column of the Schedule hereto have, under section 51 (1) and (2), been raised to meet the expense of providing such buildings as aforesaid :

Now, therefore, in pursuance of the powers vested in me by section 71 of the Elementary Education Laws, 1933 to 1950, I, the Governor, do hereby order that in order to provide for the annual interest and sinking fund in respect of the loans aforesaid the sums of money mentioned in the fourth column of the said Schedule hereto be recovered respectively from the church or churches, monastery or throne and the Greek-Orthodox inhabitants of the towns and villages mentioned in the second column of the said Schedule in manner provided by section 72 of the above Laws.
