THE VILLAGE AUTHORITIES LAWS, 1931 TO (No. 2) 1937.

SPECIAL AUTHORIZATION UNDER SECTION 13A (1) AND 13A (3).

I, S. W. C. Dunlop, Commissioner of the District of Larnaca, in exercise of the powers conferred on the Governor by section 13A (1) and 13A (3) of the Village Authorities Laws, 1931 to (No. 2) 1937, and delegated to me under Notification No. 172 published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, do hereby authorize Mr. Polydoros Antoniou, Mukhtar of Ormidhia, to issue, on the application in writing of a Police Officer of any rank not lower than that of Sergeant, Class II, or any Police Officer in charge of a Police Station, and of any Excise Officer, warrants for the purposes of the said sections of the said Laws.

THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 TO 1949.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 to 1949, the following rules made by the Committee of the Irrigation Division of "Skledros" Prodhromos, in the District of Limassol, are published in the *Gazette*.

IRRIGATION DIVISION OF "SKLEDROS" PRODHROMOS.

Rules.

These rules may be cited as the Irrigation Division of "Skledros" Prodhromos (Amendment) Rules, 1949, and shall be read as one with the Irrigation Division of "Skledros" Prodhromos Rules, 1938 (hereinafter referred to as "the principal Rules"), and the principal Rules and these rules may together be cited as the Irrigation Division of "Skledros" Prodhromos Rules, 1938 and 1949.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words "ten shillings" and the substitution therefor of the words "three pounds".
