#### THE WATER (DOMESTIC PURPOSES) VILLAGE SUPPLIES LAW, 1948. No. 515.

Bye-laws made by the Water Commission of Lasa Village under Section 29.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, 1948, the Water Commission of Lasa village hereby make the following bve-laws :-

1. These bye-laws may be cited as the Village Domestic Water Supply (Lasa) Bye-laws, 1950.
2.—(1) Subject to the provisions of paragraphs (2) and (3) of this bye-law, the Village Domestic Water Supply (Elea) Bye-laws, 1950, published in the Gazette of 1st November, 1950,

(a) be deemed to be bye-laws made by the Water Commission of Lasa and to be incorporated herein, and

apply to the village of Lasa.

(2) The bye-laws set out in Part I of the Schedule hereto shall be substituted for the corresponding bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950.
(3) Those bye-laws of the Village Domestic Water Supply (Elea) Bye-laws, 1950, mentioned

in Part II of the Schedule hereto, shall not apply to the village of Lasa.

## Bye-laws to be substituted.

Bye-law 2.—In these bye-laws, unless the context otherwise requires—
"Commissioner" means the Commissioner of the District of Paphos and includes an

Assistant Commissioner of that District;

"Law" means the Water (Domestic Purposes) Village Supplies Law, 1948, and any law amending or substituted for the same;

"Village" means the village of Lasa;
