- (b) the Commission shall, in each year and until final repayment of the amount borrowed, insert in the annual estimates as a charge on its revenues the annual instalment payable in the year to which such estimates relate;
- (c) the sum borrowed shall be utilized by the Commission for the purpose of improving the streets within the village.

2. For the purposes of securing the repayment of the sum due under the loan the Commission is hereby authorized, subject to any prior mortgage thereon, to mortgage to the Lender all fees, charges and rates now payable or hereafter to become payable to the Commission under the provisions of the Public Health (Villages) Laws, 1936 to 1948.

ORDER IN COUNCIL No. 2451 MADE UNDER SECTION 3.

In exercise of the powers vested in me by section 3 of the Forest Laws, 1939 and 1948, I, the Governor, with the advice of the Executive Council, do hereby order as follows :—

1. This Order may be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) (Amendment) Order, 1950, and shall be read as one with the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to 1949 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to 1950.

2. The Schedule to the principal Order is hereby amended as follows :-(a) By the deletion therefrom of the areas Nos. 1, 3, 10 and 27 (relating to the villages of Lymbia, Ayia Varvara, Dhali and Ayious Trimithias respectively) and the substitution therefor of the following areas :--

1. Lymbia in the District of Nicosia:
