

No. 540. THE ELEMENTARY EDUCATION LAWS, 1933 TO 1950.

NOTICE UNDER SECTION 73 (1).

In exercise of the powers vested in me by section 73 (1) of the Elementary Education Laws, 1933 to 1950, and otherwise, I, the Governor, do hereby direct that the additional tax mentioned in section 65 of the said Laws payable by the Mohammedan taxpayers of the villages mentioned in the Schedule hereto shall be increased in the year of 1951 by such rate per thousand as is shown opposite the name of each village to provide the amount required for the payment of loans or annual maintenance of the Moslem Schools of the said villages, respectively.

THE VILLAGES (ADMINISTRATION AND IMPROVEMENT)
LAWS, 1950.

APPOINTMENT OF MEMBERS UNDER SECTION 7.

Whereas the area of Kantara, being an area deemed to have been declared under the provisions of section 3 (2) of the Summer Resorts (Development) Laws, 1938 and 1946, as a summer resort for the purposes of the aforesaid Laws, is deemed, under the provisions of section 3 of the Villages (Administration and Improvement) Laws, 1950, to have been declared to be an improvement area and is such an area for the purposes of the last mentioned Laws :

And whereas it is necessary to appoint members of the Board of such an improvement area ;

Now, therefore, in exercise of the powers vested in me by section 7 (1) of the Villages (Administration and Improvement) Laws, 1950, I, the Governor, do hereby appoint the following persons to be members of the
